The Assembly Housing Committee reports Assembly Bill No. 1344 favorably, without amendment.

This bill establishes the New Jersey Boarding Home Advisory Council, the purpose of which would be to advise the interdepartmental boarding home policy committee established pursuant to section 17 of the "Rooming and Boarding House Act of 1979," P. L. 1979, c. 496 (C. 30:1A-2).

The interdepartmental committee is intended to coordinate the plans and efforts of the several State departments and agencies concerned in the regulation of boarding houses, rooming houses and residential health care facilities. It is chaired by the Commissioner of the Department of Human Services and includes representation from the Health and Community Departments, the Public Advocate and the Ombudsman for the Institutionalized Elderly, together with "such other State and local agencies as may be designated" by the chairman.

This 15-member advisory committee would include owners and operators of boarding houses (2) and residential health care facilities (2), residents of such facilities (2), a representative of an organization representing operators of such facilities (1), the health care professions (1), a county office on aging (1), a municipal building code department (1), and advocacy organizations for the mentally ill (1) and the physically disabled (1); persons who "work or knowledge or interests" relate to such facilities (who may include specifically local elected officials, social workers, county prosecutors, and person knowledgeable in building and fire safety) (2); and the chairman of the Assembly Health and Human Resources Committee (1).

This bill was pre-filed for introduction in the 1986 session pending technical review. As reported, the bill includes the changes required by technical review, which has been performed.

The Senate Institutions, Health and Welfare Committee favorably reports Assembly Bill No. 1344 with committee amendments.

As amended, this bill establishes a 16 member New Jersey Boarding Home Advisory Council in the Department of Human Services. The council is directed to: make policy recommendations to the interdepartmental policy coordinating committee established under the "Rooming and Boarding House Act of 1979," P. L. 1979, c. 496, regarding the development and coordination of licensing and enforcement standards in boarding houses and residential health care facilities and the provision of services to their residents; advise the Departments of Human Services, Community Affairs and Health regarding methods for identication of boarding houses and residential health care facilities for which no license has been issued; and, advise and comment on regulations regarding these facilities.

The members of the council shall be appointed by the Commissioner of Human Services in consultation with the Commissioners of Community Affairs and Health, the Public Advocate, the Public Guardian for Elderly Adults and the Ombudsman for the Institutionalized Elderly. The members shall include owners and operators of rooming and boarding houses and residential health care facilities; residents of these facilities; and persons who represent operators of these facilities, health care professions, a county office on aging, a municipal building code department, an organization which advocates for mentally ill persons, and an organization which advocates for physically disabled persons. The Chairmen of the General Assembly Health and Human Resources Committee and the Senate Institutions, Health and Welfare Committee, or their designees, shall serve as ex officio members of the council.

The committee amended the bill to add the Chairman of the Senate Institutions, Health and Welfare Committee, or his designee, as an ex officio member of the council.

This bill is identical to Senate Bill No. 1518 Sca which the committee also reported favorably on this date.
