#### STATEMENT

This bill provides that counties shall grant volunteer firemen, first aid, rescue squad workers and volunteer ambulance drivers time off from work with pay in order to respond to alarms within the municipality in which they are working and which they serve.

There is presently this privilege for municipal employees.

### STATE OF NEW JERSEY

DATED: FEBRUARY 4, 1985

Senate Bill No. 339 OCR, as amended by the committee, would permit counties to allow county employees who are members of a volunteer fire company, volunteers in a first aid or rescue squad, or volunteer drivers of municipal ambulances to time off with pay when the employees are called to respond to alarms during the hours of their employment.

The bill would also authorize the governing body of each county to promulgate rules and regulations to carry out the provisions of the bill.

The committee reported the bill favorably, as amended.

# STATE OF NEW JERSEY

DATED: MAY 17, 1984

Senate Bill No. 339 would require paid time off from work for county employees who are members of a volunteer fire company, volunteers in a first aid or rescue squad, or volunteer drivers of municipal ambulances, serving the municipality, when the employees are called to respond to alarms occurring during the hours of their employment.

Under N. J. S. 40A:9-160.1, similar protection is currently provided for county employees who are called to volunteer duty during the hours of their employment.

The committee amendments authorize county governing bodies to promulgate rules and regulations to carry out the provisions of the bill.
