An Act concerning fees for qualifying academic certificates and amending N. J. S. 18A:6-41.

- 1 Be it enacted by the Senate and General Assembly of the State

#### Provisions:

This bill increases the fee from \$5.00 to \$30.00 for any person who applies to the Department of Education's Bureau of Teacher Certification for a qualifying academic certificate and provides for a \$20.00 refund to any person whose credentials and other evidence are insufficient to entitle the person to a certificate.

#### BACKGROUND:

Currently, pursuant to N. J. A. C. 6:11–3.3, the State Board of Education has the authority to make changes in the fee charged to school personnel who have their credentials certified by the Department of Education. However, the Department of Education also performs the same service for other professions, e.g., chiropractors, accountants (CPA's), undertakers, etc. As with certificates for school personnel, the Department of Education reviews whether or not the person has fulfilled the required college or professional school credit requirements. However, the fee for persons other than school personnel is statutorily fixed at \$5.00 while the fee charged to school personnel is \$30.00. Consequently, the fees that school personnel must pay are subsidizing the service being performed for CPA's, chiropractors, and any other professional applying for "qualifying academic certificates." This bill would bring the statutory fee structure for such professionals into conformity with current fee structure for school personnel.

#### Provisions:

This bill increases the fee from \$5.00 to \$30.00 for persons who apply for a qualifying academic certificate and provides for a \$20.00 refund of this fee to any person whose credentials and other evidence are insufficient to entitle the person to a certificate.

#### BACKGROUND:

A "qualifying academic certificate" certifies that an individual has the basic academic education required by law to be admitted to a licensing examination for practice as a physician, dentist, chiropodist, pharmacist, certified public accountant or any other profession which requires basic academic credentials (N. J. S. 18A:6-40).

In 1982-83, over 4,500 applications were reviewed by the department. These fees were last changed in 1971 (P. L. 1971, c. 266).

A-888, sponsored by Assemblywoman Marie S. Mihler, R-Monmouth, which increases the fee for a teaching certificate from \$5 to \$30, the first increase in this fee in more than 40 years. The bill provides for a \$20 refund for individuals whose credentials are insufficient to entitle them to a certificate.

S-1756, sponsored by State Senator Francis J. McManimon, D-Mercer, which provides that the four initial acupuncturist members of the Acupuncturists Examining Board shall receive certification in New Jersey as acupuncturists by virtue of their appointment. Those members must, by law, already be certified as acupuncturists in another state. The bill retains the jurisdiction of the State Board of Medical Examiners over the Acupuncture Examining Board.

A-980, sponsored by Assemblyman John S. Watson, D-Mercer, which earmarks \$124,500 from payments to municipalities for cost of general assistance for St. Francis Medical Center for reimbursement for cost of indigent care.
