AN ACT concerning charity racing days for the developmentally disabled and amending P. L. 1977, c. 200.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. Section 1 of P. L. 1977, c. 200 (C. 5:5-44.2) is amended to read
2 as follows:

3 1. Each holder of a permit to hold or conduct horse race meetings
4 shall, with the approval of the New Jersey Racing Commission be
5 allotted **[one]** *3* racing **[day]** *days* in addition to the days autho-
6 rized by the New Jersey Racing Commission pursuant to P. L. 1940,
7 c. 17 (C. 5:5-22 et seq.); provided, however, that should any permit
8 holder reject the additional **[day]** *days*, the commission may allot
9 **[it]** *them* among the remaining permit holders, and provided
10 further that the provisions of this section shall not apply where
11 to do so would require the breach of an agreement entered into by
12 the commission. Said additional **[day]** *days* shall be known as
13 "Charity Racing **[Day]** *Days* for the Developmentally Disabled."

EXPLANATION—Matter enclosed in bold-faced brackets **[thus]** in the above bill
is not enacted and is intended to be omitted in the law.

Matter printed in italics *thus* is new matter.

This bill increases from one to three the number of "Charity Racing Days" for the developmentally disabled that a holder of a permit to conduct horse racing meetings can schedule. These proceeds are distributed to organizations designated by the New Jersey State Developmental Disabilities Council.

The three "Charity Racing Days" would be in addition to the racing days authorized by the New Jersey Racing Commission.

According to the sponsor's statement, the "additional days are being authorized because the funds that were derived from one Charity Racing Day have been seriously eroded by prior actions of the Legislature."

Governor Thomas H. Kean today signed legislation to require persons who apply for a moped license or learner's permit to furnish proof of age and identity.

The legislation, S-335, was sponsored by Senator C. Louis Bassano, R-Union.

It would require an applicant for a permit or a license to furnish proof that he or she is 15 years of age. It would also require that proof of identity be furnished once for the permit and once again for the actual operator's license.

The legislation is designed to overcome situations in which permits or licenses have been issued to those under the age of 15 years of age. The legislation is effective 45 days from date of enactment.

The Governor also signed:

S-888, sponsored by Senator Wynona Lipman, D-Essex, to establish the principle that children born out of wedlock have the same rights to parent-child relationships and to benefits from their parents as children born in wedlock. The legislation is designed to facilitate attempts by the Division of Public Welfare to obtain support from fathers who refuse to admit paternity.

A-583, sponsored by Assemblyman John Doyle, D-Ocean, to increase from 25 percent to 50 percent the amount of capital funds which state-chartered banks may invest in real property used in the operation of their business.

A-1589, sponsored by Assemblyman Richard VanWagner, D-Monmouth, to provide for two additional "Charity Racing Days for the Developmentally Disabled" at each race track in the state. Currently, each track establishes one day per year for the charity.
