An Acr concerning arson investigation units and amending P. L. 1981, c. 409.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. Section 1 of P. L. 1981, c. 409 (C. 40A:14-7.1) is amended to
- 2 read as follows:
- 3 1. a. The governing body of any municipality which has esta-
- 4 blished a paid or part-paid fire department or force may, by ordi-
- 5 nance, create an arson investigation unit within the fire department
- 6 or force and provide for the maintenance, regulation and control
- 7 thereof. The arson investigation unit shall be responsible for
- 8 conducting investigations of arson, suspicious fires or explosions
- 9 within the municipality.
- 10 b. Only paid members of a paid or part-paid fire department or
- 11 force may be assigned to an arson investigation unit created pur-
- 12 suant to this section. Before any member shall be assigned to an
- 13 arson investigation unit, he shall have successfully completed [a
- 14 basic training course for police officers at a school an appropriate
- 15 course of training approved by the Police Training Commission
- 16 and an arson investigation training course approved by the Depart-
- 17 ment of Law and Public Safety.
- 18 c. Any member of a fire department or force who is assigned to
- 19 an arson investigation unit pursuant to this section shall attend
- 20 and successfully complete in-service training programs as required

- d. Any member of a fire department or force who is assigned full-time to an arson investigative unit pursuant to this section shall have the same powers and authority of police officers within the municipality while engaged in the actual performance of arson investigation duties.
- 1 2. This act shall take effect immediately.

#### STATEMENT

This bill modifies the training requirements of members of a fire department or force assigned to an arson investigation unit. Currently, a member has to complete a basic training course for police officers, much of the training of which would not be necessary for a member of an arson investigation unit. This bill permits the Police Training Commission to design a course specifically for members of arson investigation units and omit those areas of training not relevant to arson investigations.

Governor Thomas H. Kean has signed the following bills:

S-1479, sponsored by State Senator Edward T. O'Connor, Jr., (Hudson), which increases from 2 percent to 5 percent the aggregate amount of assets a domestic property and casualty insurer can invest in investments not specifically permitted under New Jersey law, and permits the insurer to maintain their investment securities physically outside the State.

S-1655, sponsored by State Senator John P. Caufield, (D-Essex), which requires the Police Training Commission to design a course of training specifically for members of arson investigation units in fire departments.

A-185, sponsored by Assemblyman Wayne R. Bryant, (D-Camden), which requires 72 hours advance public notice of the closing of any State, county or municipal road that will be closed for more than 48 hours.

 $\underline{A-72}$ , sponsored by Assemblyman Robert P. Hollenbeck, (D-Bergen), which prohibits the retail sale of items used in home construction which violate the Uniform Construction Code.

 $\underline{A-275}$ , sponsored by Assemblyman William E. Flynn, (D-Middlesex), which requires the issuance of photo-identification cards to adult recipients of aid to families with dependent children as a condition of receiving such aid.
