# STATE OF NEW JERSEY

Senate Bill No. 1065 supplements chapter 14 of Title 58 of the Revised Statutes in order to provide that contracting municipalities pay their annual apportioned costs for services by the Passaic Valley Sewerage Commission in four installments. The four installment payments are to be made on February 1, May 1, August 1, and November 1 of each year.

At present, the contracting municipalities must pay their annual apportioned costs in one payment.

Senate Bill No. 1065 would establish a quarterly payment schedule for amounts due to the Passaic Valley Sewerage Commission by municipalities under contract with the commission.

This bill, as Senate Bill No. 3361, was reported favorably by this committee in the 1980-1981 legislative session. It passed the Senate by a vote of 31-0, and did not receive a vote in the General Assembly. The amendments made by this committee in the last session are incorporated in Senate Bill No. 1065.

The committee notes that the description of this bill as provided in the Legislative Index is incorrect and misleading. The bill does not affect the membership of the commission.

Assembly Bill No. 187 -- which permits professional corporations to utilize the term "a professional corporation" or the abbreviation "P.C."

Assembly Bill No. 234 -- which provides for the protection of certain consumer rights.
