- The Office of Legislative Services (OLS) cannot provide a cost estimate for Assembly Bill
 No. 2899 because it has no information regarding the cost of each safety and accountability
 audit. Furthermore, the bill does not state how often the audits should be conducted.
- The OLS notes that there are dozens, if not hundreds, of State and local organizations that provide services to victims of domestic violence. It is not clear whether or not the Division on Women would need to employ extra personnel in order to fulfill the mandate of the bill.
- This bill would require the implementation of Recommendation #4 from a 2006 report issued by the New Jersey Domestic Violence Fatality and Near Fatality Review Board. The OLS notes that section 4 of P.L.2003, c.225 directs the Domestic Violence Fatality and Near Fatality Review Board to "conduct a Statewide domestic violence safety and accountability audit."

BILL DESCRIPTION

Assembly Bill No. 2899 of 2012 directs the Division on Women in the Department of Community Affairs to conduct an audit of the coordination of community responses to domestic violence. The department would sponsor safety and accountability audits and would be required to include a systematic analysis of intra-agency and interagency policies and procedures used by law enforcement agencies and the court system when investigating and prosecuting cases of



domestic violence-related fatalities and near fatalities, and by State and local agencies and organizations when providing services to victims of domestic violence.

This bill would implement Recommendation #4 from a 2006 report issued by the New Jersey Domestic Violence Fatality and Near Fatality Review Board. In its report, the board found from case reviews that professionals who came in contact with victims failed to demonstrate knowledge about domestic violence that is essential to providing appropriate care, information, and referrals to these victims. Furthermore, the board found that there was no mechanism for these professionals to communicate with each other to evaluate the totality of the response provided to the people involved, with the result that no one communicated the danger that existed to these victims.

FISCAL ANALYSIS

EXECUTIVE BRANCH

OFFICE OF LEGISLATIVE SERVICES

The OLS cannot determine the fiscal impact of this bill because it has no information regarding the cost of each safety and accountability audit and how often the audits will be conducted. It is not clear whether or not this bill would require the Division on Women to employ extra personnel to conduct the audits. The OLS notes that the responsibility for conducting a Statewide domestic violence safety and accountability audit was delegated to the New Jersey Domestic Violence Fatality and Near Fatality Review Board by section 4 of P.L.2003, c.225 (C.52:27D-43.17d).

The Domestic Violence Safety and Accountability Audit (DVSAA) was developed in 1996 by Praxis International of Duluth, Minnesota. Audits are conducted by interdisciplinary teams that examine how institutions charged with intervening in cases of domestic violence organized their practitioners to perform their duties. The audit teams looks at how agency practices, influenced by formal job descriptions and work cultures, ensure the safety of their victims and the accountability of offenders. The DVSAA has six distinct steps: (1) forming and preparing an interagency audit team (that includes domestic violence advocates); (2) determining which aspects of case processing the team will investigate; (3) determining the scope of the investigation; (4) collecting data from each point of institutional action on the case, including the relationship between the data produced at different points of intervention; (5) analyzing the data; and (6) preparing findings that lead to specific recommendations.

Furthermore, the board found that there was no mechanism for these professionals to communicate with each other to evaluate the totality of the response provided to the people involved, with the result that no one communicated the danger that existed to these victims.

FISCAL ANALYSIS

EXECUTIVE BRANCH

The Office of Management and Budget (OMB) and DCF estimate State costs of \$1,395,000, \$1,383,000, and \$1,386,000, respectively, for the bill's first, second, and third years of implementation. Anticipated first-year DCF expenditures are associated with the following State costs:

- approximately \$312,000 in State salary costs, for two program specialists and a supervisor in the Division on Women to perform and administer the audit activities;
- approximately \$34,000 in other State operating costs (office space, supplies, computers, and communications) associated with the new Division on Women positions; and
- \$1,050,000 in State grants-in-aid to localities, to fund personnel in county-based non-profit or governmental entities to assist with local administration of the audit activities. This funding level would support one part-time position in each of the 21 counties at \$50,000 per county.

Estimated second- and third-year expenditures are similar to those in the first year, except for an annual one percent State salary increase in the second and third years and one-time, first-year State computer and workstation expenditures of \$15,000.

The DCF notes that its estimated expenditures are based on the bill's requirements for safety and accountability audits at the State, county, and local/municipal levels. The DCF indicates that its estimates would be reduced if the bill limited audit activities to State, regional, and county-level reviews of domestic violence policies, protocol, coordination, and resources. The DCF's estimates do not otherwise provide detailed assumptions regarding the agencies and organizations to be included in the audit activities or the pace or frequency of audit activities.

OFFICE OF LEGISLATIVE SERVICES

The OLS concurs with the Executive that the bill would likely generate increased direct State costs and grants-in-aid costs related to funding the required audit and analysis activities. However, the OLS cannot verify or refute the Executive's overall estimates due to uncertainty as to how many State and local agencies and organizations would be involved in the audit activities and how frequently the audits would be conducted.

The OLS notes that the bill requires an analysis of domestic violence-related policies and procedures used by "law enforcement agencies and the court system" and "State and local agencies and organizations" but does not otherwise specify the scope of entities subject to the audits. Moreover, the bill does not dictate the pace or duration of audit activities or whether any entities may be re-audited. There are numerous courts, law enforcement agencies, domestic violence programs, health care providers, and other State, county, and municipal entities that provide services to victims of domestic violence and that might be subject to the audits. For example:

- The DCF currently lists 27 county-based organizations operating domestic violence programs across the State;
- the U.S. Department of Justice identified a total of 550 State and local law enforcement agencies in New Jersey during a 2008 census; and
- New Jersey's Department of Health currently lists over 1,300 hospitals, ambulatory care facilities, and other acute care facilities operating across the State.

Thus, actual costs incurred by DCF could vary greatly, depending on the types and numbers of entities to be audited, the pace of audits, and the overall duration and frequency of audit activities. As the Executive's assumptions are unclear regarding these sources of potential cost variation, the OLS cannot determine whether the Executive's estimates are reasonable. However, the OLS notes that DCF would have some discretion under the bill to adjust the pace of audit activities to match available resources.

The OLS also notes that the responsibility for conducting a Statewide domestic safety and accountability audit was previously delegated to the New Jersey Domestic Violence Fatality and Near Fatality Review Board by section 4 of P.L.2003, c.225 (C.52:27D-43.17d). This board is charged with reviewing domestic violence-related fatalities and near fatalities to identify their causes, their relationships to public and private service delivery systems, and their methods of prevention. Available information does not indicate whether the board has conducted any safety and accountability audits beyond a one-county pilot project completed prior to 2009. In the past, the board has received federal funding for its activities from the Office of Violence Against Women in the U.S. Department of Justice. If identical or similar federal funding could be identified or reallocated to support implementation of the bill, it is possible that a portion of State costs might be offset.

The systematic analysis would also examine policies and procedures used by State and local agencies and organizations when providing services to victims of domestic violence.

This bill would implement Recommendation #4 from a 2006 report issued by the New Jersey Domestic Violence Fatality and Near Fatality Review Board. In making this recommendation, the board found from case reviews that professionals who came in contact with victims (including professionals from the medical community, the child welfare system, and other organizations and government agencies) failed to demonstrate knowledge about domestic violence that is essential to providing appropriate care, information, and referrals to these victims. Furthermore, the board found that there was no mechanism for these professionals to communicate with each other to evaluate the totality of the response provided to the people involved, with the result that no one communicated the danger that existed to these victims.

FISCAL ANALYSIS

EXECUTIVE BRANCH

The Office of Management and Budget (OMB) and DCF estimate State costs of \$1,395,000, \$1,383,000, and \$1,386,000, respectively, for the bill's first, second, and third years of implementation. Anticipated first-year DCF expenditures are associated with the following State costs:

- approximately \$312,000 in State salary costs, for two program specialists and a supervisor in the Division on Women to perform and administer the audit activities;
- approximately \$34,000 in other State operating costs (office space, supplies, computers, and communications) associated with the new Division on Women positions; and
- \$1,050,000 in State grants-in-aid to localities, to fund personnel in county-based non-profit or governmental entities to assist with local administration of the audit activities. This funding level would support one part-time position in each of the 21 counties at \$50,000 per county.

Estimated second- and third-year expenditures are similar to those in the first year, except for an annual one percent State salary increase in the second and third years and one-time, first-year State computer and workstation expenditures of \$15,000.

The DCF notes that its estimated expenditures are based on the bill's requirements for safety and accountability audits at the State, county, and local/municipal levels. The DCF indicates that its estimates would be reduced if the bill limited audit activities to State, regional, and county-level reviews of domestic violence policies, protocol, coordination, and resources. The DCF's estimates do not otherwise provide detailed assumptions regarding the agencies and organizations to be included in the audit activities or the pace or frequency of audit activities.

OFFICE OF LEGISLATIVE SERVICES

The OLS concurs with the Executive that the bill would likely generate increased direct State costs and grants-in-aid costs related to funding the required audit and analysis activities. However, the OLS cannot verify or refute the Executive's overall estimates due to uncertainty as

to how many State and local agencies and organizations would be involved in the audit activities and how frequently the audits would be conducted.

The OLS notes that the bill requires an analysis of domestic violence-related policies and procedures used by "law enforcement agencies and the court system" and "State and local agencies and organizations" but does not otherwise specify the scope of entities subject to the audits. Moreover, the bill does not dictate the pace or duration of audit activities or whether any entities may be re-audited. There are numerous courts, law enforcement agencies, domestic violence programs, health care providers, and other State, county, and municipal entities that provide services to victims of domestic violence and that might be subject to the audits. For example:

- The DCF currently lists 27 county-based organizations operating domestic violence programs across the State;
- the U.S. Department of Justice identified a total of 550 State and local law enforcement agencies in New Jersey during a 2008 census; and
- New Jersey's Department of Health currently lists over 1,300 hospitals, ambulatory care facilities, and other acute care facilities operating across the State.

Thus, actual costs incurred by DCF could vary greatly, depending on the types and numbers of entities to be audited, the pace of audits, and the overall duration and frequency of audit activities. As the Executive's assumptions are unclear regarding these sources of potential cost variation, the OLS cannot determine whether the Executive's estimates are reasonable. However, the OLS notes that DCF would have some discretion under the bill to adjust the pace of audit activities to match available resources.

The OLS also notes that the responsibility for conducting a Statewide domestic safety and accountability audit was previously delegated to the New Jersey Domestic Violence Fatality and Near Fatality Review Board by section 4 of P.L.2003, c.225 (C.52:27D-43.17d). This board is charged with reviewing domestic violence-related fatalities and near fatalities to identify their causes, their relationships to public and private service delivery systems, and their methods of prevention. Available information does not indicate whether the board has conducted any safety and accountability audits beyond a one-county pilot project completed prior to 2009. In the past, the board has received federal funding for its activities from the Office of Violence Against Women in the U.S. Department of Justice. If identical or similar federal funding could be identified or reallocated to support implementation of the bill, it is possible that a portion of State costs might be offset.

The Senate Budget and Appropriations Committee reports favorably Senate Bill No. 1152.

This bill directs the Division on Women (reorganized into DCF pursuant to P.L.2012, c.16) to conduct an audit of the coordination of community responses to domestic violence. The department would sponsor community safety and accountability audits and would be required to include a systematic analysis of intra-agency and interagency policies and procedures used by law enforcement agencies and the court system when investigating and prosecuting cases of domestic violence-related fatalities and near fatalities. The systematic analysis would also examine policies and procedures used by State and local agencies and organizations when providing services to victims of domestic violence.

This bill would implement Recommendation #4 from a 2006 report issued by the New Jersey Domestic Violence Fatality and Near Fatality Review Board. In making this recommendation, the board found from case reviews that professionals who came in contact with victims (including professionals from the medical community, the child welfare system, and other organizations and government agencies) failed to demonstrate knowledge about domestic violence that is essential to providing appropriate care, information, and referrals to these victims. Furthermore, the board found that there was no mechanism for these professionals to communicate with each other to evaluate the totality of the response provided to the people involved, with the result that no one communicated the danger that existed to these victims.

This bill is identical to Assembly Bill No. 2899, as also considered by the committee.

FISCAL IMPACT:

- approximately \$312,000 in State salary costs, for two program specialists and a supervisor in the Division on Women to perform and administer the audit activities;
- approximately \$34,000 in other State operating costs (office space, supplies, computers, and communications) associated with the new Division on Women positions; and
- \$1,050,000 in State grants-in-aid to localities, to fund personnel in county-based non-profit or governmental entities to assist with local administration of the audit activities. This funding level would support one part-time position in each of the 21 counties at \$50,000 per county.
