STATE OF NEW JERSEY

ADOPTED APRIL 28, 1969

AN ACT concerning county and municipal deputy superintendents of weights and measures, and amending section 51:1-45 of the Revised Statutes.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. Section 51:1-45 of the Revised Statutes is amended to read as
2 follows:

3 51:1-45. The governing body of each county and municipality
4 shall fix the numbers of assistant superintendents therein, and by
5 resolution may authorize the superintendent to appoint them. *The*
6 *governing body of each county and municipality may provide for*
7 *the position of a deputy superintendent and by resolution may*
8 *authorize the superintendent to appoint one of his assistants as*
9 *deputy superintendent. The deputy superintendent shall act and*
10 *have all the powers and duties of a superintendent when: (a) so*
11 *directed by the superintendent, and a directive to that effect is filed*
12 *with the State superintendent; or (b) a vacancy occurs in the office*
13 *of a county or municipal superintendent, in which event he shall*
14 *serve in that capacity until such superintendent returns to duty or*
15 *his successor is duly appointed and qualified. Such deputy superin-*
16 *tendent and assistants shall be under the direct control of their*
17 *respective superintendents. They shall have all the powers and*
18 *duties of a superintendent in making inspections, tests and measure-*
19 *ments.*

1 2. This act shall take effect immediately.

AN ACT concerning deputy county superintendents of weights and measures, and supplementing chapter 1 of Title 51 of the Revised Statutes.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. Each county superintendent of weights and measures is au-
2 thorized to designate and appoint one of his assistant superintend-
3 ents to serve as deputy superintendent of weights and measures
4 for the county. The deputy superintendent shall serve at the
5 pleasure of the superintendent and, during the superintendent's
6 absence or inability, shall have the same powers and perform all
7 the duties of the superintendent. The deputy superintendent shall
8 continue to retain his assistant superintendent classification and
9 all the rights and benefits thereof. As deputy he shall continue to
10 receive the salary to which he is entitled as assistant superintendent
11 and such additional compensation for his duties as deputy as the
12 board of chosen freeholders of the county may prescribe.

1 2. This act shall take effect immediately.
