1 AN ACT concerning confiscated animals and supplementing Title 4 of
2 the Revised Statutes.

4 **BE IT ENACTED** *by the Senate and General Assembly of the State*
5 *of New Jersey:*

7 1. The costs of sheltering, caring for, or treating any animal that
8 has been confiscated from a person arrested pursuant to the provisions
9 of R.S.4:22-47 by an agent of the New Jersey Society for the
10 Prevention of Cruelty to Animals, or any other person authorized to
11 make an arrest pursuant to article 2 of chapter 22 of Title 4 of the
12 Revised Statutes, until the animal is adjudged forfeited or until the
13 animal is returned to the owner, shall be borne by the owner of the
14 animal.

16 2. This act shall take effect immediately.
