The Assembly Veterans and Military Affairs Committee reports favorably Senate Bill No. 3084.

This bill permits active members of the Military Order of the Purple Heart (MOPH) to affix purple heart emblems on the license plates of their motor vehicles in accordance with the regulations to be promulgated by the Division of Motor Vehicles for the use, design, material and placement of the emblems. The bill does not require the State to make the emblems available to members of the MOPH. Therefore, those members wishing to display the emblems must secure them at their own expense.
