AN ACT concerning motor vehicles, and amending section 39:3-27 of the Revised Statutes.

1 BE IT ENACTED by the Senate and General Assembly of the State of New  
2 Jersey:

1 1. Section 39:3-27 of the Revised Statutes is amended to read as follows:  
2 39:3-27. No fee shall be charged for the registration of motor vehicles  
3 not used for pleasure or hire, owned by the United States, the State of New  
4 Jersey, a municipality, [or] county or district commission or other public  
5 corporation, duly authorized volunteer fire department, hospital, humane so-  
6 ciety, an anti-cruelty society in this State, New Jersey wing of the Civil Air  
7 Patrol incorporated by the Act of July 1, 1946 (Public Law 476-79th Con-  
8 gress), or the American Red Cross. These vehicles shall be registered and  
9 display number plates as provided in this subtitle or the director may, in  
10 his discretion, issue special registration certificates and special number plates  
11 for any of these motor vehicles which shall be valid for such motor vehicles  
12 until the transfer of ownership or the destruction of such motor vehicles at  
13 which time the special registration shall expire. Upon the expiration of any  
14 special registration the registration certificate and special number marker  
15 shall be returned to the director; *provided, however*, upon proper applica-  
16 tion to the director the special registration and special number marker may be

17 transferred to another motor vehicle acquired by the owner to whom the spe-  
18 cial registration and marker were issued.

1 2. This act shall take effect immediately.

STATEMENT

The purpose of this bill is to provide special registration for certain ve-  
hicles entitled to registration without fee, which will eliminate the necessary  
renewal of such registration each year, and the administrative work necessary  
thereto.
