AN Act providing for the retirement of life guard officers and life guards employed in cities of the fourth class in this State, now or hereafter having a population in excess of twenty thousand inhabitants, and providing a pension for life guard officers and life guards so retired.

1 *BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:*

1 1. In all cities of the fourth class in this State, now or hereafter having a popula-
2 tion in excess of twenty thousand inhabitants as ascertained by the preceding Fed-
3 eral census, any member of the life guard force in service during the year when this
4 act takes effect, whether employed as an officer or a guard, who shall have served on
5 such force for a period of fifteen consecutive years, and shall have attained the age
6 of forty years, may be retired upon half pay by the governing body of any such city
7 or upon his own application may be retired upon half pay as aforesaid.

1 2. Any officer or member of any such life guard force, who shall have received
2 permanent disability in the performance of his duty shall, upon the certificate of the
3 beach surgeon, or other physician designated by the governing body, be retired
4 upon a pension equal to half of his said salary at the time of retirement.

1 3. A fund shall be created in the following manner for the purpose of paying
2 such pensions, to wit: There shall be deducted from every payment of salary to
3 each member of the life guard force in such municipality two per centum of the
4 amount thereof; municipalities shall raise by taxation and pay into such fund yearly
5 an amount equal to four per centum of the total salaries paid to members of the
6 life guard force. There shall be added to such fund the following moneys: All fines

7 imposed upon any member of the life guard force; all moneys given or donated for
8 the purpose of such fund; all moneys deducted from the salary of any member of
9 the life guard force on account of absence, loss of time, and half of all rewards
10 paid to the said life guard force, or to any member thereof. In case at any time there
11 shall not be sufficient money in such pension fund for the purposes of said fund the
12 governing body shall include in any tax levy a sum in addition to amounts hereto-
13 fore contributed which shall be sufficient to meet the requirements of the fund, and
14 such sum shall be raised by tax levy no longer than is necessary to meet the re-
15 quirements of such pension fund. Whenever such pension fund shall exceed an
16 amount which the governing body shall by resolution from time to time determine
17 to be adequate for such pension fund, no moneys, except the two per centum of sala-
18 ries, and the fines, donations and rewards specified in this act, shall be paid into such
19 fund unless and until the amount of such fund shall fall below the amount thus
20 determined to be adequate.

1 4. There shall be appointed by the mayor or chief executive officer, with the
2 advice and consent of the governing body of such municipality, a life guard pension
3 commission consisting of four members, one of whom shall be a superior officer of
4 such life guard force and one a life guard, and two citizens who are not members
5 of such life guard force. The members of such life guard pension commission shall
6 serve for a term of four years, and until their successors are appointed and duly
7 qualified and shall not receive any compensation for their services. Each person so
8 appointed to such life guard pension commission shall take an oath of office before
9 the mayor or other chief executive officer of such municipality to the effect that
10 he will faithfully discharge the duties of the office.

1 5. The said life guard pension commission shall have the management and con-
2 trol of said fund and is hereby empowered to make all necessary rules and regula-
3 tions not inconsistent with this act. All moneys belonging to said life guard pen-
4 sion fund shall be paid over to the treasurer of such municipality, who shall give
5 bond in such amount from time to time as the governing body of such municipality
6 shall determine. All moneys not needed for the immediate payment of such pen-
7 sions shall be invested by such life guard pension commission in interest bearing
8 bonds of such municipality or in other interest bearing securities in which savings

9 banks of this State are authorized to invest their funds. No moneys shall be paid
10 out of said fund by such treasurer except upon the warrant of such life guard com-
11 mission, such warrant to be signed by such member or members of such life guard
12 pension commission as shall be designated by such commission.

1 6. This act shall take effect immediately.

10 determine the length of service or the amount of the year's salary by averaging the
11 salary heretofore received by said life guard or officer during the past three years
12 or in other equitable manner and may determine in such case who constitutes a year's
13 salary and a year's service. All moneys belonging to said life guard pension fund
14 shall be paid over to the treasurer of such municipality, who shall give bond in such
15 amount from time to time as the governing body of such municipality shall de-
16 termine. All moneys not needed for the immediate payment of such pensions shall
17 be invested by such life guard pension commission in interest-bearing bonds

30 the age of sixteen years, then the said pension shall be paid to the dependent parent
31 or parents of said life guard officer or life guard.

1 1. Section one of the act of which this act is amendatory be and the
2 same is hereby amended so that the same shall read as follows:

3 1. In all cities of the fourth class in this State, as ascertained by the
4 preceding Federal census, any member of the life guard force in service
5 during the year when this act takes effect, whether employed as an officer
6 or a guard, who shall have served on such force for a period of [fifteen
7 consecutive] twenty years, and shall have attained the age of [forty]
8 forty-five years, and for a period of ten years preceding his application
9 has been continuously in such service, may be retired upon half pay by the
10 governing body of any such city or upon his own application may be retired
11 upon half pay as aforesaid.

1 2. Section three of the act of which this act is amendatory be and the
2 same is hereby amended so that the same shall read as follows:

3 3. A fund shall be created in the following manner for the purpose of
4 paying such pensions, to wit: There shall be deducted from every payment
5 of salary to each member of the life guard force in such municipality
6 ~~two~~ four per centum of the amount thereof; municipalities shall raise
7 by taxation and pay into such fund yearly an amount equal to ~~four~~ per
8 centum of the total salaries paid to members of the life guard force. There
9 shall be added to such fund the following moneys: All fines imposed upon
10 any member of the life guard force; all moneys given or donated for the
11 purpose of such fund; all moneys deducted from the salary of any mem-
12 ber of the life guard force on account of absence, loss of time, and half of
13 all rewards paid to the said life guard force, or to any member thereof. In
14 case at any time there shall not be sufficient money in such pension fund
15 for the purposes of said fund the governing body shall include in any tax
16 levy a sum in addition to amounts heretofore contributed which shall be
17 sufficient to meet the requirements of the fund, and such sum shall be raised
18 by tax levy no longer than is necessary to meet the requirements of such
19 pension fund. Whenever such pension fund shall exceed an amount which
20 the governing body shall by resolution from time to time determine to be
21 adequate for such pension fund, no moneys, except the ~~two~~ four per
22 centum of salaries, and the fines, donations and rewards specified in this
23 act, shall be paid into such fund unless and until the amount of such fund
24 shall fall below the amount thus determined to be adequate.

1 3. This act shall take effect immediately.

STATEMENT

The purpose of this act is to strengthen the pension funds maintained for life guards in cities of the fourth class. It increases the percentage to be paid by members of the fund, raises the age limit and extends the period of service prior to retirement. The act imposes no additional burden upon the municipality; the entire increase being borne by the members of the fund.
