L. 1918, Chapter 236, Sect. 605 - A51
Introduced January 14 by Pierson.
February 13 - Passed Assembly, amended by committee). *COPY NO. 1*
(This section not amended)
February 27 - Passed Senate.
March 4 - Signed by Governor.
Statement on bill:

"This act constitutes a general
revision of the tax laws."
(copy of Sect. 605 of original bill enclosed).

Amended L. 1921, Chapter 62, Sect. 1 - A12
Introduced January 17 by Pierson.
Not amended during passage.
Statement on bill:

"This amendment rewrites Section 605 of the
Tax Act (Revision, 1918), consequently it is
impractical to bracket old matter and underscore
new matter. Practically, the only change is
placing the responsibility for the payment of the
school, county and State taxes upon the governing
body, who alone have authority to borrow money
for such payments. Under the old language, the
collector was instructed to make these payments,
but not having the power to borrow money, was
unable to comply with the law, consequently this
amendment places the responsibility for the
payment in the hands of the officials who have
the power to borrow the money."

Introduced January 28 by Mackay.
February 18 - Amended in Senate.
February 26 - Passed Senate.
March 6 - Passed Assembly.
March 13 - Signed by Governor.
Statement on bill.

Amended L. 1933, Chapter 182, Sect. 1 - S115
Introduced January 30 by Young.
Not amended during passage.
Statement on bill:

"Section 605, Article 6 above set forth
was amended in 1924..

"By mistake no date was fixed for the
payment of the first half of monies due counties.

"The above amendment reads exactly as the
present law, Chapter 215, Laws of 1924, with the
following words inserted the same being underlined:

" on or before the fifteenth day of June
in each year."

Amended L. 1933, Chapter 266, Sect. 8 - A209
Introduced February 20 by Naughtright.
June 5 - Passed Assembly, amended (amendment not available).
June 20 - Passed Senate.
June 21 - Signed by Governor.

Amended L. 1935, Chapter 318, Sect. 1 - S382
Introduced June 24 by Wolber.
June 25 - Amended and passed in Senate.
June 25 - Passed Assembly.
June 29 - Signed by Governor.
