AN ACT to amend "An act concerning the registration of certain motor vehicles in the State, and supplementing chapter three, Title 39, of the Revised Statutes," approved April twelfth, one thousand nine hundred and forty-eight (P. L. 1948, c. 28).

1 BE IT ENACTED *by the Senate and General Assembly of the State of New*  
2 *Jersey:*

1 1. Section one of the act of which this act is amendatory is amended  
2 to read as follows:

3 1. No fee shall be charged for the registration of [a] any motor vehicle  
4 owned by any resident of the State of New Jersey who has qualified or may  
5 qualify under the provisions of Public Law 663 79th Congress of the  
6 United States of America (August 8th, 1946); *provided*, this act shall apply  
7 only to one vehicle of passenger type for each eligible individual at any one  
8 time and shall not apply to vehicles used for hire and that no such vehicle  
9 shall be registered unless it is equipped with such special attachments and  
10 devices as the Director of the Division of Motor Vehicles in the Department  
11 of Law and Public Safety may deem necessary to provide for the safe op  
12 eration thereof by such individual.

1 2. This act shall take effect immediately.

7 of America (August 8th, 1946), and who is the holder of a current driver's  
8 license issued by this State, if such motor vehicle is equipped with such spe  
9 cial attachments and devices as the Director of the Division of Motor Vehicles  
10 in the Department of Law and Public Safety may deem necessary to provide  
11 for the safe operation thereof by such person.

1 2. This act shall take effect immediately.

Amend page 1, section 1, line 3, after "registration" insert ", in any year or years,"; omit "any" insert "one"; after "vehicle" insert "of passenger type, which is not to be used for hire".

Amend page 1, section 1, line 4, omit "may" insert "shall".

Amend page 1, section 1, line 6, omit "; *provided*, this act shall apply".

Amend page 1, section 1, line 7, omit entire line.

Amend page 1, section 1, line 8, omit entire line.

Amend page 1, section 1, line 9, omit "shall be registered unless it" insert "and who is the holder of a current driver's license issued by this State, if such motor vehicle".
