The Assembly Higher Education Committee favorably reports Senate Bill No. 1052 [1R].

This bill establishes the Millicent Fenwick Research Professorship in Education and Public Issues at Monmouth College. This will be a distinguished professorship designed to further innovative teaching and learning as well as research and public service. The chair will further the work of the Governor's School of Public Issues at Monmouth College, a school which brings theoretical principles from academic disciplines to bear in devising responses to social and public issues.

The professorship is named after Millicent Fenwick, a member of the New Jersey General Assembly from 1970 to 1973 and Congresswoman from New Jersey from 1974 to 1982, who has been committed to public service throughout her career.

This professorship was established in fiscal year 1989 through the Appropriations Act with an appropriation of \$75,000. Funding was also provided in FY 1990. The Senate amended the bill to remove an appropriation since there were funds appropriated in the FY 1991 budget for this scholarly chair. This bill is identical to Assembly Bill No. 3066 of 1990 with AHE committee amendments.

A representative from the Department of Higher Education indicated that the department supports the bill. A representative from the Association of Independent Colleges and Universities also indicated that they are in favor of the bill.

The Assembly Appropriations Committee reports favorably Senate Bill No. 1052 (1R).

Senate Bill No. 1052 (1R) statutorily establishes the Millicent Fenwick Research Professorship in Education and Public Issues at Monmouth College. This professorship has been funded since fiscal year 1989 through the Appropriations Act with an annual amount of \$75,000.

This is to be a distinguished professorship designed to further innovative teaching and learning as well as research and public service. The chair furthers the work of the Governor's School of Public Issues at Monmouth College, a school which brings theoretical principles from academic disciplines to bear in devising responses to social and public issues. The professorship is named after Millicent Fenwick, a member of the New Jersey General Assembly from 1970 to 1973 and Congresswoman from New Jersey from 1974 to 1982, who has been committed to public service throughout her career.

This bill is identical to Assembly Bill No. 3066 (1R).

This bill contains no appropriation and has no fiscal impact.

The Senate Education Committee favorably reports this bill without committee amendments.

This bill establishes the Millicent Fenwick Research Professorship in Education and Public Issues at Monmouth College. This will be a distinguished professorship designed to further innovative teaching and learning as well as research and public service. The chair will further the work of the Governor's School of Public Issues at Monmouth College, a school which brings theoretical principles from academic disciplines to bear in devising responses to social and public issues.

This professorship was established in fiscal year 1989 through the Appropriations Act with an appropriation of \$75,000. Funding was also provided in FY 1990.

The professorship is named after Millicent Fenwick, a member of the New Jersey General Assembly from 1970 to 1973 and Congresswoman from New Jersey from 1974 to 1982, who has been committed to public service throughout her career.

The bill appropriates \$75,000 for the professorship.

An identical bill, Senate No. 2068, passed the Senate and was released by the Assembly Higher Education Committee during the previous legislative session. However, no action was taken by the General Assembly.

#### BACKGROUND

The following scholarly chairs are currently supported by the State: the Einstein Chair for Scholarly Studies at the Institute for Advanced Studies; the Richard J. Hughes Chair for Constitutional and Public Law and Service at Seton Hall; the Alfred E. Driscoll Chair in Pharmaceutical/Chemical Studies at Fairleigh Dickinson University; the Will and Ariel Durant Chair in the Humanities at St. Peters; the Small Business and Entrepreneurship Chair at Rutgers; and, the Raoul Wallenberg Visiting Professorship in Human Rights at Rutgers.

Also, since fiscal year 1984, an appropriation of \$75,000.00 has been included in the State budget for a Chair of Women's Studies at Douglass College. Legislation to establish this chair in statute was enacted during the previous session as P.L.1988, c.42.

This bill was pre-filed for introduction in the 1990 session pending technical review. As reported the bill includes the changes required by technical review which has been performed.
