The Assembly Judiciary, Law and Public Safety Committee reports favorably Assembly Bill No. 880.

Currently, child support and alimony payments which are collected by the county probation department and turned over to the recipient are subject to delays if the payor makes late payments to the department, or if errors within the department slow the process. This bill would expedite collections by allowing payments to be made by credit card, electronic funds transfer, or other methods deemed feasible by the probation department, in accordance with a recommendation by the New Jersey Commission on Child Support. Possible uses of electronic fund transfer would include direct deposit of income withholding by employers, support payments through automatic withholding from an obligor's bank account, obligor approved and initiaited withdrawal from a bank account by use of automatic teller machines or the use of credit cards for support payments on a walk-in basis at the county probation department or on a prearranged basis for periodic charges to the obligor's credit card account.

This bill was prefiled for introduction in the 1990 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.
