INTRODUCED DECEMBER 12, 1988

By Senator GRAVES

- 1 AN ACT ¹[establishing a central reporting agency for] requiring
 the reporting of ¹ automobile theft or salvage and
 supplementing Title 17 of the Revised Statutes.
- 5 BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:
- 7 1. a. Any insurer transacting automobile insurance in this State shall:
- 9 (1) report the theft or salvage of a motor vehicle to the National Automobile Theft Bureau (hereinafter referred to as the
- 11 NATB) in accordance with the constitution and operating procedures of the NATB; and
- (2) reimburse the NATB for the costs of the performance of its duties under its constitution and operating procedures in a
 manner to be determined by the governing board of the NATB.
 - b. The National Automobile Theft Bureau shall:
- 17 (1) receive a report of the theft or salvage of a motor vehicle made by an insurer under subsection (a) of this section and shall
- include that information in the central index file which it maintains; and
- 21 (2) cooperate with an insurer who submits a report and with a law enforcement agency which is conducting an investigation and
- release information when appropriate and necessary which it has received on a claim or an investigation.
- c. Any information provided to the NATB pursuant to this section shall be confidential and shall not be subject to public
- inspection. Such information shall not be subject to subpoena or subpoena duces tecum unless, after a notice and hearing, a court
- determines that an ongoing investigation would not be jeopardized by compliance with a subpoena or subpoena duces
- 31 tecum.

The Assembly Law, Public Safety and Corrections Committee favorably reports Senate Bill No. 3122 with amendment.

This bill requires an insurer of automobiles to report the theft or salvage of a motor vehicle to the National Automobile Theft Bureau for inclusion in the NATB's central index file. An insurer also is required to reimburse the NATB for the costs of operation in a manner determined by the governing board of the NATB. Information provided to the NATB is confidential and is not subject to public inspection.

The National Automobile Theft Bureau, which has its Eastern Division in Woodbury, NY, is a non-profit organization engaged in motor vehicle loss prevention. The bureau maintains a computerized program containing reports of stolen or abandoned motor vehicles throughout the United States. In 1985, the bureau's files contained more than 9.2 million reports which were available to law enforcement agencies and insurance companies investigating claims involving stolen or abandoned motor vehicles. The availability of such information is essential not only to facilitate the successful investigation of motor vehicle thefts, but also to frustrate and prevent insurance fraud schemes. The reporting requirement set forth in this bill will ensure our State's participation in this program and thus assure that the bureau's information base is up-to-date and accurate.

The committee amended the title to reflect that the bill requires the reporting of theft or salvage rather than the establishment of a central reporting agency.

The Senate Law, Public Safety and Defense Committee reports favorably Senate Bill No. 3122.
