STATEMENT

The notice of settlement protects the buyer of real estate from liens or sale of the property which occur between the date of the notice of settlement and the date of closing. This bill increases the number of days this protection can be afforded the buyer from 20 days to 45 days. This is needed because even though the notice of settlement is filed with the county recording officer, it is not actually recorded in many counties until many days have elapsed. The increase to 45 days takes into account delays in recording the notice of settlement and provides maximum protection to the buyer from intervening liens and claims.

The Assembly County Government Committee reports Senate Bill No. 1195 favorably.

Senate Bill No. 1195 amends section 5 of P. L. 1979, c. 406 (C. 46:16A-5) to extend the effective period for a notice of settlement from 20 to 45 days.

A notice of settlement protects the buyer of real estate from any intervening liens or subsequent sales of the property during the interim period between the filing of the notice of sale of the property and the date on which the deed for the property is actually recorded by the county. According to the sponsor, the extension is necessary because in certain cases it takes more than 20 days for a county to actually record a deed.

The Senate County and Municipal Government Committee reports favorably Senate Bill No. 1195.

Senate Bill No. 1195 amends section 5 of P. L. 1979, c. 406 (C. 46:16A-5) to extend the effective period for a notice of settlement to 45 days. Under current law, the effective period is 20 days from the date of filing. A notice of settlement protects the buyer of real estate from liens or a sale which might occur between the date of the filing of the notice and the recording of the deed after the date of the closing.

According to the sponsor, the extension is needed to protect the buyer when recording of the deed is delayed.

This bill was pre-filed for introduction in the 1986 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.
