- 7 any property taxes, water or sewer payments, *or* parking or pay-
- 8 roll taxes imposed *or collected by the municipality* against that
- 9 property or the owner or owners of that property are delinquent
- 10 at the time of the determination or judgment, the governing body
- 11 of the municipality constituting the taxing district in which the
- 12 property is located may apply the refund, or such portion thereof
- 13 as may be necessary, including any accrued interest, against the
- 14 delinquency.
- 14 If the total amount of the refund is equal to or exceeds the total
- 15 amount of the delinquency, the lien against the property for unpaid
- 16 taxes shall be extinguished, and the balance, if any, remaining after

The Assembly Municipal Government Committee favorably reports Senate Bill No. 1619 with Aca.

This bill allows municipalities to apply real property tax refunds awarded to a taxpayer by the county board of taxation or the tax court against delinquent water or sewer payments or payroll or parking taxes.

Currently, the law permits municipalities to apply property tax refunds resulting from county board of taxation or tax court decisions towards the payment of delinquent property taxes. This bill permits the municipality to also apply the refunds against delinquent water or sewer payments or parking or payroll taxes. The committee amended the bill to clarify that it applies not just to taxes imposed against the real property for which a refund was granted, but also to certain payments and fees owed to the municipality by the owners of that property.

The Senate County and Municipal Government Committee reports favorably and with committee amendments Senate Bill No. 1619.
