**INTRODUCED MARCH 7, 1988**

**By Assemblymen HAYTAIAN and SHUSTED**

1 **AN ACT** concerning bail for persons charged with criminal or  
quasi-criminal offenses and supplementing Title 2A of the New  
3 Jersey Statutes.

5 **BE IT ENACTED** by the Senate and General Assembly of the  
State of New Jersey:

7 1. a. A person charged with a criminal or quasi-criminal  
offense may post the required amount of bail in the form of:

9 (1) Full cash;

11 (2) A surety bond executed by a corporation authorized under  
chapter 31 of Title 17 of the Revised Statutes; or

13 (3) A bail bond secured by real property situated in this State  
with an unencumbered equity equal to the amount of bail  
undertaken plus \$5,000.00.

15 b. A court may designate the amount of bail without  
designating the form in which the bail may be posted. When the  
17 court does not designate the form, bail may be posted in any  
combination of the forms authorized in subsection a. of this  
19 section.

21 c. When bail is posted in the form of a bail bond secured by  
real property, the owner of the real property, whether the person  
admitted to bail or a surety, shall also file an affidavit containing:

23 (1) A legal description of the real property;

(2) A description of each encumbrance on the real property;

25 (3) The market value of the unencumbered equity owned by the  
affiant; and

27 (4) A statement that the affiant is the sole owner of the  
unencumbered equity.

29 2. When a person charged with a criminal or quasi-criminal  
offense posts bail, \$10.00 of the total amount required to be  
31 posted as bail shall be paid in cash as a nonrefundable bail fee.  
The bail fee shall be forwarded to the State Treasury to be  
33 deposited in a separate account for use by the Violent Crimes

## STATEMENT

The northwest part of New Jersey is one of the fastest growing areas of the State, both in terms of population and business development. This has created an urgent need for educational services, especially among women, many of whom are contemplating a return to work.

This bill establishes a Northwest New Jersey Regional Women's Center at Centenary College in Hackettstown, New Jersey. The center would offer educational programs and counselling, continuing education courses, career planning and placement services and access to cultural programs to women of all ages and from all backgrounds who are New Jersey residents.

The bill appropriates \$150,000.00 for this purpose and requires Centenary College to submit a report to the Legislature and the Governor detailing its use of the funds within two years of the effective date.

The Assembly Higher Education and Regulated Professions Committee favorably reports Assembly Bill No. 2675.

This bill establishes a Northwest New Jersey Regional Women's Center at Centenary College in Hackettstown, New Jersey. Under the bill's provisions, the center is to offer educational programs and counseling, continuing education courses, career planning and placement services, and access to cultural programs to women of all ages and backgrounds who are New Jersey residents.

The bill appropriates \$150,000.00 to Centenary College to finance the construction of the center and the provision of equipment, supplies and staff. Finally, the bill directs the college to report to the Governor and the Legislature within two years of the bill's effective date on the use of the funds appropriated to the college.

BACKGROUND:

Centenary College is a four year independent women's college which was founded in 1867. Some of the programs offered at the college provide the option of a two year associate degree. The college also offers a coeducational evening and weekend continuing education program.

Centenary College is accredited by the Middle States Association of Colleges and Schools.

The Assembly Appropriations Committee favorably reports Assembly Bill No. 2675.

Assembly Bill No. 2675 establishes the Northwest New Jersey Regional Women's Center at Centenary College in Hackettstown. The center is to offer educational programs and counseling, continuing education courses, career planning and placement services, and access to cultural programs to New Jersey women.

The college is to submit a report within two years to the Governor and the Legislature on the use of the funds appropriated.

FISCAL IMPACT:

The bill appropriates \$150,000.00 to Centenary College for construction of the center and to provide equipment, supplies and staff.

The Senate Revenue, Finance and Appropriations Committee reported Assembly Bill No. 2675 favorably.

This bill appropriates \$150,000.00 to Centenary College to establish a Northwest New Jersey Regional Women's Center. The center would offer educational programs, career counseling and placement, continuing education courses and access to cultural programs for women living in the northwest section of the State.

The monies appropriated to the college may be used for the construction of the center, the provision of equipment and supplies, the salaries of clerical, teaching and support staff and such other support as is necessary for the center. It is the committee's understanding that after receiving this appropriation, the college would seek funds from the private sector and through revenue received through the provision of services by the center.

The college is required to report to the Governor and the Legislature within two years of the effective date of the act concerning the use of the funds received.

Centenary College is a nonsectarian private college, offering two and four year undergraduate degree programs.

This bill is identical to Senate Bill No. 2172.

**FISCAL IMPACT:**

The bill appropriates \$150,000.00 from the General Fund to Centenary College.
