An Acr establishing an Office for Prevention of Mental Retardation and Developmental Disabilities in the Department of Human Services and making an appropriation therefor.

- 1 Be it enacted by the Senate and General Assembly of the State

- 1 1. The Legislature finds and declares that: approximately 2%
- 2 of the residents of this State are developmentally disabled and
- 3 more than 50,000 of these persons are developmentally disabled
- 4 school age children; 30,000 to 40,000 residents suffer from mental

- 6 several times more are mildly retarded and can live independent
- 7 or semi-independent lives; pregnancy during adolescence increases
- 8 the incidence of mental retardation and developmental disabilities
- 9 because of the heightened risk of premature birth, low birth-
- 10 weight, birth complications and birth defects; in 1984 in New
- 11 Jersey, there were 6,682 births to women ages 18 years and under;

The Assembly Appropriations Committee favorably reports this bill, as amended.

Assembly Bill No. 2339 as amended establishes the Office for Prevention of Mental Retardation and Developmental Disabilities in the Department of Human Services and makes an appropriation of \$500,000.00. The office shall develop a long-range comprehensive plan; encourage cooperative research among State governmental agencies, universities and private agencies; develop public information campaigns; coordinate prevention education programs; stimulate expanded and new services; and recommend executive and legislative action.

The Governor's Council on the Prevention of Mental Retardation shall act in an advisory capacity. The council's eleven member executive committee, which has full power to act in-lieu of the full council, and the Commissioner of Human Services shall report annually to the Governor and the Legislature on the status of prevention programs.

FISCAL IMPACT:

There is appropriated to the Department of Human Services from the General Fund the amount of \$500,000.00. The Commissioner of Human Services shall execute written agreements with the Department of Health, Education and Environmental Protection to coordinate budget requests and provide the proper procedures for disbursement of funds and programmatic and fiscal monitoring.

COMMITTEE AMENDMENTS:

The committee amended the bill, at the recommendation of the Sub-committee on Government Operations, to give the director of this office the authority to retain expert consultants on a contract basis, but regular employees shall be selected, hired and serve under Civil Service procedures. The appropriation was increased from \$250,000.00 to \$500,000.00.

The Senate Revenue, Finance and Appropriations Committee reported this bill favorably, with amendments.

Assembly Bill No. 2339, as amended, establishes the Office for Prevention of Mental Retardation and Development Disabilities in the Department of Human Services, and further provides for the establishment of an 11 member Executive Committee of the Governor's Council on the Prevention of Mental Retardation.

The Office for the Prevention of Mental Retardation and Developmental Disabilities is charged with, but not limited to the responsibility for:

- a. Developing a long-range comprehensive plan for the prevention of mental retardation and developmental disabilities in accordance with the priorities established by the Governor's Council on the Prevention of Mental Retardation;
- b. Encouraging cooperative programs of research among State governmental departments and agencies, universities and private agencies;
- c. Developing public information campaigns about the causes of developmental disabilities and the means for preventing developmental disabilities;
- d. Coordinating public education programs about the causes and prevention of developmental disabilities and determining professional in-service training needs in these areas;
- e. Stimulating expanded and new services for the prevention of developmental disabilities; and
- f. Making recommendations to the Commissioner of Human Services regarding any needed executive or legislative action.

The office is to be administered by a director appointed by, and serving at the pleasure of the Commission of the Department of Human Services after consultation with the Governor's Council on the Prevention of Mental Retardation. The director is to serve in

a full-time capacity and receive a salary commensurate with the responsibilities of the office. The director is authorized to appoint, retain or employ officers, experts or consultants on a contract basis or otherwise, and may employ investigators or other professionally qualified personnel.

The Governor's Council on the Prevention of Mental Retardation is to serve as an advisory council to the Commissioner of the Department of Human Services, and to the Office for Prevention of Mental Retardation and Development Disabilities. The Council is required to establish an 11 member Executive Committee, to be chaired by one of the four voting cabinet members of the executive committee upon election by the Governor's council, and this Executive Committee shall have full power to act in lieu of the full council.

COMMITTEE AMENDMENTS:

The committee amended the bill to reduce the appropriation from \$500,000.00 to \$400,000.00.

FISCAL IMPACT:

The bill provides for an appropriation of \$400,000 from the General Fund to carry out the purposes of the act.

Stating that, "we aim to make preventing mental retardation one of our top priorities," Governor Thomas H. Kean today signed legislation establishing the Office for Prevention of Mental Retardation and Development Disabilities in the Department of Human Services.

At the public signing in his outer office, Governor Kean pointed out that, "we know that fully one half of the severely retarded cases in our mental institutions could have been avoided."

"We already know that steps can be taken to prevent mental retardation before it touches a life," Governor Kean continued, "and this new office will allow us to help thousands of New Jerseyans to be born healthy and untouched by developmental disabilities."

The legislation, A-2339, was sponsored by Assemblymen Rodney Frelinghuysen, R-Morris, Harold Colburn, R-Burlington and Senator C. Louis Bassano, R-Union. Governor Kean thanked the sponsors for their work in establishing the Office and the appropriation of \$400,000 to commence its work.

The establishment of the Office came as a result of the recommendations of the Governor's Council on the Prevention of Mental Retardation which was created by Executive Order in 1984.

Governor Kean praised the work of his wife Debby who served as Honorary Chairman of the Governor's Council.

Among the responsibilities of the new office are; the development of a comprehensive long-range plan for the prevention of mental retardation and developmental disabilities, the encouragement of cooperative research programs among State agencies, universities and private agencies, the development of public information campaigns about the causes of and means for preventing developmental disabilities and the stimulation of expanded and new services for prevention.

The legislation also calls for the 25 member Governor's Council on the Prevention of Mental Retardation to be made a permanent advisory body to the Commissioner of Human Services and the new Office of Prevention.

Governor Kean called for the creation of the Office of Prevention in his 1986 Annual Message.

The legislation is effective immediately.
