The Assembly Municipal Government Committee favorably reports Senate Bill No. 1140 and Assembly Bill No. 1996 (OCR) with Aca.

This bill permits a municipality, by ordinance, to offer rewards not exceeding \$500.00 each, for the detection and apprehension of any person guilty of purposely or knowingly damaging tangible property of another by an act of graffiti. The reward is to be paid after conviction, and upon recommendation of the principal municipal law enforcement officer.

An "act of graffiti" is defined in the bill as "the drawing, painting or making of any inscription on a bridge, building, public transportation vehicle, rock, wall, sidewalk, street or other exposed surface on public or private property without permission of the owner."

The committee amended the bill to specify the particular section of the code of criminal justice under which an "act of graffiti," as defined in the bill, would be found. That section is N. J. S. 2C:17–3, criminal mischief. This amendment is necessary because by itself an act of graffiti does not constitute a violation of the law; therefore no conviction for that particular act could be obtained. As amended, the bill provides for the payment of an award after conviction of the offense of criminal mischief, in violation of N. J. S. 2C:17–3, by means of an act of graffiti.

The Senate County and Municipal Government Committee reports favorably the Senate Committee Substitute for Senate Bill No. 1140 and Assembly Bill No. 1993 OCR.

Senate Committee Substitute for Senate Bill No. 1140 and Assembly Bill No. 1996 OCR permits the governing body of any municipality to offer a reward of up to \$500.00 for the detection and apprehension of persons guilty of acts of graffiti.

Under the provisions of the committee substitute, the governing body may pay the reward upon conviction of a person for an act of graffiti. However, no reward shall be paid to any public employee whose responsibility it is to investigate or enforce the law or to any member of the public employee's household.

Governor Thomas H. Kean signed the following legislation:

AJR-14, sponsored by Assemblyman Joseph Palaia, R-Monmouth, establishes a 14 member commission to study the services and programs available to hearing impaired children.

The 14 member commission, to be organized by the Director of the Division of the Deaf, will be made up of two members of the Senate, two members of the Assembly, six public members appointed by the Governor, two of whom shall be hearing impaired and two who shall be advocates for services to the hearing impaired, the Director of the Divison of the Deaf and the Commissioners of Education, Health and Human Services.

There are approximately 1,800 school age children in New Jersey who are classified by public school districts as suffering from hearing impairment.

The resolution is effective immediately.

S-1140/A-1996, sponsored by Senator Raymond Lesniak, D-Union and Assemblyman John Girgenti, D-Passaic, permits the governing body of any municipality to offer a reward of up to \$500 for the detection and apprehension of any person guilty of criminal mischief by means of an act of "graffiti."

It is hoped that this law will assist law enforcement in the difficult task of apprehending those who deface the property of others.

The bill shall take effect immediately.

<u>S-1148</u>, sponsored by Senator Raymond Lesniak, D-Union and Assemblyman Charles Catrillo, R-Hudson, creates a "rebuttable presumption" that a person charged with operating a motor vehicle without insurance was actually uninsured at the time of the offense unless he fails to produce at trial a valid insurance identification card or insurance policy in force at the time of the offense.

The legislation is effective immediately.

<u>A-1646</u>, sponsored by Assemblyman Harry McEnroe, D-Essex, establishes a procedure for the reimbursement of counties and municipalities that incur the costs of training police personnel who are subsequently hired by another county or municipality.
