An Act concerning certain costs incurred in the training and hiring of county and municipal police officers at d supplementing chapter 14 of Title 40A of the New Jersey Statutes.

- 1 BE IT ENACTED by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. Whenever a person who resigned as a member of a county or
- 2 municipal police department is appointed to the police department
- 3 of another county or municipality within 120 days of resignation,
- 4 and that person held a probationary appointment at the time of
- 5 resignation or held a permanent appointment for 30 days or less
- 6 prior to resignation, the county or municipality appointing the
- 7 person is liable to the former county or municipal employer, as
- 8 appropriate, for the total certified costs incurred by the former
- 9 employer in the examination, hiring, and training of the person.

Assembly Bill No. 1646 Aca supplements chapter 14 of Title 40A of the New Jersey Statutes to establish a procedure to provide for the reimbursement of the costs incurred by a county or municipality in the hiring and training of a police officer who resigns his position within the first two years of his permanent appointment and, within 120 days of the date of his resignation, is hired by another county or municipality.

Under the provisions of the bill, if a police of cer resigns during the period of his probationary appointment or within the first 30 days of his permanent appointment and is hired by another county or municipality within 120 days of the date of his resignation, the county or municipality which has hired that individual is required to reimburse that individual's former employer for the total certified costs that county or municipality had incurred in examining, hiring and training that individual.

In the case of a police officer who resigns a remanent appointment he has held for more than 30 days, but for less than two years, and who is hired by another county or municipality within 120 days of the date of resignation, the county or municipality which has hired that individual is required to reimburse that individual's former employer for one half of the total certified costs that county or municipality had incurred in examining, hiring and training that individual.

The bill stipulates that it is the responsibility of the hiring county or municipality to notify the individual's former county or municipal employer and, within 120 days of receiving notice of the certified costs involved, to reimburse the individual's former employer.

The bill also defines "examination costs" as the costs of all qualifying examinations and public advertisements for the examinations and "training costs" as the fees for the police training course required pursuant to P. L. 1961, c. 56 (C. 52:17B-66 et seq.) and the base salary paid the individual while attending that course.

The committee amendment changes the reimbursement requirement from 45 days to 120 days.

The committee reports the bill, as amended, favorably.

This bill was pre-filed for introducton in the 1986 session pending technical review. As reported and amended, the bill includes the changes required by technical review which has been performed.

The Senate County and Municipal Government Committee reports favorably Assembly Bill No. 1646 OCR.

In the case of a police officer who resigns a permanent appointment he has held for more than 30 days, but for less than two years, and who is hired by another county or municipality within 120 days of the date of resignation, the county or municipality which has hired that individual is required to reimburse that individual's former employer for one-half of the total certified costs that the county or municipality had incurred in examining, hiring and training that individual.

The bill stipulates that it is the responsibility of the hiring county or municipality to notify the individual's former county or municipal employer and, within 120 days of receiving notice of the certified costs involved, to reimburse the individual's former employer.

The bill also defines "examination costs" as the costs of all qualifying examinations and public advertisements for the examinations and "training costs" as the fees for the police training course required pursuant to P. L. 1961, c. 56 (C. 52:17B-66 et seq.) and the base salary paid the individual while attending that course.
