STATEMENT

A thorough and efficient education for the youth of New Jersey requires that they become familiar with the history and government of their State and its communities. This knowledge is necessary to strengthen the bonds that relate individual citizens to each other and to their community and government.

This bill amends the existing requirement for at least two years of American history during high school to provide that material on the history and government of New Jersey and its political subdivisions be incorporated within this course of study.

The Assembly Education Committee favorably reports this bill as amended.

As amended, this bill mandates the incorporation of material on New Jersey in the two-year course of study in United States history which is required for all students in public high schools in the State (N. J. S. 18A:35–1).

At present the only statutory mandate for instruction relating to New Jersey is the requirement for a course in the geography, history and government of New Jersey to be offered in elementary schools (N. J. S. 18A:35-3). Most school districts in the State offer this required New Jersey course in grade 4 or 5.

The committee amendment removes from the bill a requirement that material on the government of New Jersey and political subdivisions be included in the course of study.

This bill was pre-filed for introduction in the 1986 session pending technical review. As amended the bill includes the changes required by technical review which has been performed.

The Senate Education Committee favorably reports this bill with amendments.

As amended, this bill would require that material on the history and government of the State of New Jersey be included in the two-year course of study of United States history which is currently required of all high school students.

BACKGROUND:

Currently, the only statutory course requirements for high school students are the United States history course, health and physical education, and drug and alcohol education. In addition, the State Department of Education requires four years of English, two years of mathematics, one year of science, a semester of art education, a semester of career education, and family life education. These requirements are currently under review by the department.

A course on New Jersey civics, geography and history is required for elementary school pupils (N. J. S. 18A:35-3). This course is normally given in the fifth or sixth grade.

The committee amended this bill to require that the course include materials on the government of New Jersey and its political subdivisions. As amended, this bill is identical to Senate Bill No. 1872.

To the General Assembly:

Pursuant to Article V, Section I, Paragraph 14 of the Constitution, I am returning Assembly Bill No. 649 (2nd OCR) with my objections, for reconsideration.

This bill requires that the mandated study of United States history by high school pupils include the study of the history of the State of New Jersey. This is a laudable goal. I believe that the study of the history of New Jersey should be an integral part of the educational process in our public schools because New Jersey's future citizens cannot adequately determine the future course of the State without a firm knowledge of its past. I believe New Jersey's citizens should be as well informed about the history of their State as are students in other states. During the legislative process concerning this bill, it became apparent that other states have taken pains to insure that their students are well versed in their state's history. This bill will help to improve the understanding that New Jersey students have of the history of the State of New Jersey.

While I strongly support the need for New Jersey students to study New Jersey history, I am also sensitive to the need to avoid curriculum mandates. I firmly believe that local communities should have maximum flexibility in setting their own curriculum policies within the parameters of general requirements. For this reason, I believe it intrusive upon local school district curriculum prerogative to specify that the study of the history of New Jersey must include the study of the government of the State and its political subdivisions. This language was deleted during the legislative process and then restored prior to its passage. I believe that the bill was improved when this language was deleted. Local school districts should determine their students' courses of study regarding the history of the State of New Jersey.

Therefore, I herewith return Assembly Bill No. 649 (2nd OCR) and recommend that it be amended as follows:
