This bill would exempt the marine equipment utilized by the marine search and rescue units of volunteer firefighting organizations, and volunteer first aid, rescue or emergency squads from the certificate of ownership (i.e., "title") requirements of the "Boat Ownership Certificate Act."

The Assembly Law, Public Safety, Defense and Corrections Committee favorably reports Assembly Bill No. 165 with amendments.

As amended, Assembly Bill No. 165 creates an exemption from the fees in the Boat Ownership Certificate Act (P. L. 1984, c. 152; C. 12:7A-1 et seq.) by stating that no fee is to be charged under the act for marine equipment which is used by marine search and rescue units of volunteer firefighting organizations and volunteer first aid, rescue or emergency squads.

The committee amended the bill to exempt the described organizations only from the payment of the fees required in the Boat Ownership Certificate Act and not from all the other requirements in the act. In addition, the committee amended the bill so that it would take effect on June 15, 1987 at the same time that the entire Boat Ownership Certificate Act would take effect.

This bill was pre-filed for introduction in the 1986 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.

The Senate Law, Public Safety and Defense Committee favorably reports Assembly Bill No. 165 OCR with amendments.

As amended, this bill exempts from registration fees marine equipment used by marine search and rescue units of volunteer firefighting organizations, fire districts, and volunteer first aid, rescue or emergency squads. The exemption applies only to marine equipment used exclusively in the performance of the prescribed duties of these organizations.

The committee amended the bill to exempt marine equipment used by the above mentioned organizations from registration fees rather than titling fees, as the bill referred to the committee would have done.
