The Assembly Education Committee favorably reports this bill.

This bill permits a school board candidate to withdraw his or her name from the ballot at any time prior to the printing of the ballot.

Currently, as amended by P. L. 1985, c. 92, a candidate in a school election must withdraw his name before 4 P.M. of the 46th day before the election. In other elections, the candidate must withdraw 60 days prior to the election (R. S. 19:13–16) and ballots must be printed 43 days prior to the election (R. S. 19:14–1). There is not statutory time requirement for the printing of school election ballots.

The reason for providing for an earlier withdrawal deadline was to provide additional time for absentee voters to execute and return their ballots; however, this would not apply to school election ballots which are normally printed after the budget is adopted. This may be as late as 12 days prior to the election (N. J. S. 18A:22-32).

The Senate Education Committee favorably reports Senate Bill No. 58.

This bill permits a school board candidate to withdraw his or her name from the ballot at any time prior to the printing of the ballot.

Background:

Currently, as amended by P. L. 1985, c. 92, a candidate in a school election must withdraw his name before 4 p.m. of the 46th day before the election. In other elections, the candidate must withdraw 60 days prior to the election (R. S. 19:13–16) and ballots must be printed 43 days prior to the election (R. S. 19:14–1). There is no statutory requirement for the printing of school election ballots.

The reason for providing for an earlier withdrawal deadline was to provide additional time for absentee voters to execute and return their ballots; however, this would not apply to school election ballots which are normally printed after the budget is adopted. This may be as late as 12 days prior to the election (N. J. S. 18A:22–32).

This bill was pre-filed for introduction in the 1986 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.
