STATEMENT

This bill establishes an automatic cost-of-living increase in the income eligibility limits for the "Pharmaceutical Assistance to the Aged and Disabled" (PAAD) program that is tied to the annual cost-of-living increase in the Social Security program. The increase shall be made within three months of the determination of the cost-of-living increase and no person who is eligible shall be made ineligible for benefits because of the Social Security cost-of-living increase. The Commissioner of Human Services shall establish the program's income eligibility limits annually by regulation for single and married persons, respectively.

The Assembly Senior Citizens Committee reports favorably Assembly Bill No. 2391.

The purpose of this bill is to establish an automatic cost-of-living increase in the income eligibility limits for the "Pharmaceutical Assistance to the Aged and Disabled" (PAAD) program that is tied to the annual cost-of-living increase in the Social Security program. The increase would be made within three months of the determination of the cost-of-living increase and no person who is eligible for the PAAD program would be made ineligible for benefits because of the Social Security cost-of-living increase. The Commissioner of Human Services would establish the program's income eligibility limits annually by regulation for single and married persons, respectively.

The "Lifeline Credit Program" income eligibility limits would increase annually by the same amounts since this program uses the same income eligibility standards as the PAAD program.

The Assembly Appropriations Committee favorably reports this bill. Assembly Bill No. 2391 provides for increased income eligibility limits coupled to the cost-of-living increases in the Social Security program after January 1, 1987. This would affect recipients of the "Pharmaceutical Assistance to the Aged and Disabled" (PAAD) and the "Lifeline Programs."

This cost-of-living increase will prevent certain individuals from becoming ineligible for the pharmaceutical programs due to an increase in their Social Security benefits. The increases in State income limits would be made within three months of the determination of the Social Security increases. No person currently eligible for the programs would become ineligible during that three month period due to the cost-of-living increase.

FISCAL IMPACT:

The bill pertains to Social Security benefit increases after January 1, 1987. It is estimated that the FY 1987 appropriation from the Casino Revenue Fund for the Pharmaceutical Assistance and Lifeline programs will be sufficient to fund any additional costs barring a significant increase in Social Security benefits. Funds are available because the expected increase in eligible recipients has not materialized when income limits were increased in August, 1985 from \$12,000.00 to \$13,250.00 and from \$15,000.00 to \$16,250.00 for single persons and married couples, respectively.

The Senate Institutions, Health and Welfare Committee favorably reports Assembly Bill No. 2391 with committee amendments.

As amended by the committee, this bill increases the income eligibility limits in the "Pharmaceutical Assistance to the Aged and Disabled" (PAAD) program to \$13,650.00 and \$16,750.00 for single and married persons, respectively. The increase in the PAAD limits will be retroactive to December 31, 1986.

This bill will ensure that current PAAD recipients are not disqualified from PAAD as a result of the 1987 Social Security cost-of-living increase and that these persons will continue to receive Lifeline benefits, as eligibility for Lifeline is tied to income eligibility for PAAD.

The committee amended the bill to establish specific increases in the PAAD income eligibility limits rather than establish an automatic annual cost-of-living increase in the PAAD program. The amendments also change the effective date from 60 days following enactment to immediately and provide that the bill is retroactive to December 31, 1986.

As amended, this bill is identical to Senate Bill No. 732 4th OCR which is currently pending before the Senate.

Governor Thomas H. Kean today signed legislation to increase the income eligibility limits for participation in the "Pharmaceutical Assistance to the Aged and Disabled" (PAAD) program. This increase will allow PAAD eligibility levels to keep pace with cost of living increases in Social Security benefits. Without this adjustment, increased social security benefits may have raised a senior citizen's income above the eligibility level, thus disqualifying them from the PAAD program.

The PAAD program provides payments to pharmacies for the reasonable cost of prescription drugs to the elderly and disabled. Participants in the program pay \$2.00 for each prescription with the State paying the remaining cost.

The legislation A-2391, sponsored by Assemblyman Robert Singer, R-Ocean, Assemblyman Jack Rafferty, R-Mercer and Senator Catherine Costa, D-Burlington, raises the income eligibility level from \$13,250 to \$13,650 for a single person and from \$16,250 to \$16,750 for a married couple. This increase is effective immediately and is retroactive to December 31st, 1986.

Governor Kean stated, "I want to commend the sponsors, Assemblymen Robert Singer and Jack Rafferty, for their work in protecting the over 210,000 PAAD recipients in New Jersey. The PAAD program is a vital part of our health care services for the elderly and disabled."

The fiscal year 1988 budget sets aside \$58.2 million from the general fund and \$51.3 million from the Casino Revenue Fund for the PAAD program.

#
