An Act concerning the proceeds of the State lottery, and supplementing P. L. 1970, c. 13 (C. 5:9-1 et seq.).

This bill provides that any program of education, approved by the Department of Education or the Department of Higher Education, that serves senior citizens shall be eligible to receive proceeds from the State lottery.

The Senate Committee on Aging favorably reports Senate Bill No. 1211.

This bill provides that a program of education designed to benefit senior citizens, which has been approved by the Department of Education or the Department of Higher Education, is eligible to receive aid from the State Lottery Fund.

This bill was pre-filed for introduction in the 1986 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.

This bill is identical to Assembly Bill No. 3515 (Rooney), now pending before the Assembly Senior Citizens Committee.
