An Act concerning the purchase of prior service credit in the Teachers' Pension and Annuity Fund and amending N. J. S. 18A:66-13.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. N. J. S. 18A:66-13 is amended to read as follows:
- 2 18A:66-13. Prior service credit. A member may file a detailed
- 3 statement of school service and service in a similar capacity in
- 4 other states and in schools within and outside the United States
- 5 operated by a department of the United States Government for the
- 6 instruction of the children of United States Government officers
- 7 and employees rendered by him prior to becoming a member for
- 8 which he desires credit and on account of which he desires to

The Assembly State Government Committee reports favorably Senate Bill No. 1976.

This bill permits members of the Teachers' Pension and Annuity Fund to purchase TPAF credit for up to 10 years' service in schools within the United States which are operated by a department of the United States Government for the instruction of the children of United States Government officers and employees. Currently, the law authorizes purchase of this credit only if those schools are located outside of the United States.

The cost of the purchase is to be split between the member and the State, which pays all employer contributions to the TPAF.

The Senate State Government Committee reports favorably Senate Bill No. 1976.

Senate Bill No. 1976 of 1986 permits members of the Teachers' Pension and Annuity Fund to purchase credit for up to 10 years' service in schools within as well as outside of the United States which are operated by a government department for the instruction of children of government officers and employees. The cost of the purchase is to be split between the member and the State.

The Division of Pensions states that the average cost of a year of service in the Teachers' Pension and Annuity Fund is approximately \$2,500.00 but notes that the cost of enacting this legislation will be higher, approximately \$3,560.00, because these individuals are probably older males earning higher salaries. Therefore, if the cost is divided evenly between the members and the State, the cost to the State would initially be \$1,780.00 per member per year of service purchased. The division also indicates that this cost could be greater if the majority of those purchasing credit are older employees in the higher salary ranges. In addition, as pension benefits increase, so will the cost of operating the Pension Adjustment Program. No estimate has been provided about the number of employees likely to take advantage of this legislation.
