STATEMENT

This bill establishes the Hearing Aid Assistance for the Aged and Disabled Program in the Department of Human Services to provide up to a \$100.00 payment in a calendar year in which a hearing aid is purchased by an eligible recipient. The eligibility criteria for this program are the same as for the Pharmaceutical Assistance to the Aged and Disabled Program. These criteria include:

- (1) The person is a resident of the State of New Jersey;
- (2) The person is either disabled pursuant to the federal Social Security Act (42 U. S. C. section 416 (i)) or 65 years of age and over; and
- (3) The person's annual income is less than \$13,250.00 if single or \$16,250.00 when combined with that of his spouse if married.

This program shall be funded from the Casino Revenue Fund.

SENIOR CITIZENS

Establishes the Hearing Aid Assistance for the Aged and Disabled Program in the Department of Human Services and provides that the program shall be funded from the Casino Revenue Fund.

The Assembly Appropriations Committee favorably reports Assembly Bill No. 2303 OCR with amendments.

Assembly Bill No. 2303 (OCR), as amended establishes, in the Department of Human Services, the "Hearing Aid Assistance for the Aged and Disabled" program. The program is to provide up to \$100.00 to an eligible recipient. The eligibility criteria is the same as for the Pharmaceutical Assistance to the Aged and Disabled program (PAAD).

Those persons otherwise eligible whose hearing aid costs are covered by any other State or federal government program or insurance contract would not receive assistance from this program. Those receiving partial coverage may be entitled to reduced hearing aid assistance under this program. The funding is to be from the General Fund.

COMMITTEE AMENDMENTS:

The committee amended the bill to appropriate \$540,000.00 which represents 20% of the eligible population that may need to apply for this program.

The Senate Revenue, Finance and Appropriations Committee reported Assembly Bill No. 2303 (3rd OCR) favorably.

Assembly Bill No. 2303 (3rd OCR) appropriates \$540,000.00 to the Department of Human Services for a "Hearing Aid Assistance for the Aged and Disabled" program. The program is to provide up to \$100.00 to an eligible recipient. The cligibility criteria is the same as for the Pharmaceutical Assistance to the Aged and Disabled program (PAAD).

Those persons otherwise eligible whose hearing aid costs are covered by any other State or federal government program or insurance contract would not receive assistance from this program. Those receiving partial coverage may be entitled to reduced hearing aid assistance under this program.

The bill is identical to Senate Bill No. 2048 (OCR), as amended.

FISCAL IMPACT:

This bill appropriates \$540,000.00 from the Casino Revenue Fund to the Department of Human Services for a "Hearing Aid Assistance for the Aged and Disabled" program. The department estimates that the cost for one full year for the program will be \$3.2 million. The fiscal year 1988 budget included an appropriation of \$1.5 million for this program. The department estimates that with the appropriation included in this bill and the budget appropriation, the program can be funded for the remainder of FY 1988.

Governor Thomas H. Kean today signed the following legislation:

A-2303, sponsored by Assemblywoman Joann Smith, R-Monmouth and Senator Richard Van Wagner, D-Monmouth, establishes the Hearing Aid Assistance for the Aged and Disabled program.

The \$540,000 appropriation will allow for grants of up to \$100 per year to eligible recipients for the purchase, repair, or replacement of hearing aids.

To be eligible, a person must be disabled pursuant to the federal Social Security Act, or be over 65 years of age. The person's annual income must be less than \$13,250 if single or \$16,250 if married.

The legislation is effective in ninety days.

A-4073, sponsored by Assemblyman Wayne Bryant, D-Camden, Assemblyman Harold Colburn, R-Burlington and Senator Walter Rand, D-Camden, designates Cooper Hospital/University Medical Center in Camden as the State's specialty acute care children's hospital for the ten southern counties in New Jersey.

The designation of Cooper Hospital as the specialty acute care children's hospital for Atlantic, Burlington, Camden, Cape May, Cumberland, Gloucester, Mercer, Monmouth, Ocean and Salem counties follows the designation of Children's Hospital of New Jersey, a unit of United Hospitals Medical Center in Newark, as a similar facility.

The legislation is effective immediately.
