The Assembly Transportation, Communications and High Technology Committee reports favorably Senate Bill No. 2912 OCR with committee amendments.

This bill, as amended, imposes a \$1,000.00 fine for driving an overweight motor vehicle across a bridge which has signs posting the weight limits of the bridge in specific locations upon and nearby the bridge.

The bill, as amended by the committee, requires the warning signs to be placed at the last safe exit or detour preceding the bridge rather than at the last available turnoff from the road leading to the bridge, as specified in Senate Bill No. 2912 OCR. In addition, the committee amendments stipulate that these signs be posted and maintained by the entity which has jurisdiction over the bridge. Senate Bill No. 2912 OCR provided that a motor vehicle is in violation of this statute if the registered gross weight of the vehicle or the actual gross weight of the vehicle and load is greater than the gross weight stated on the sign. The committee amended the bill by removing the references to registered gross weight and actual gross weight and provided, instead, that a person driving a motor vehicle is in violation of this statute if the gross weight of the vehicle and load is greater than the gross posted weight limit of the bridge.

As amended by the committee, this bill is identical to Assembly Bill No. 3610 with committee amendments adopted June 29, 1987.

The Senate Law, Public Safety, and Defense Committee favorably reports Senate Bill 2912 with amendments.

As amended, this bill increases from \$100.00 to \$1,000.00 the fine for driving across a bridge a motor vehicle with a registered gross weight or with an actual weight plus load which is greater than the posted weight limit. Under current law, if the fine imposed for a violation of R. S. 39:4-75 is not paid, the violator will be imprisoned in the county jail for up to 10 days.

The committee amended the bill so that it would apply to all motor vehicles and not just commercial motor vehicles; to permit the use of the registered gross weight when the actual gross weight of the vehicle with its load cannot be readily determined; and to penalize a person under this section only when a weight limit for a bridge is posted at the last available turnoff from the road leading to the bridge, as well as on the bridge itself.
