An Acr establishing the "Catastrophic Illness in Children Relief Fund" and the Catastrophic Illness in Children Relief Fund Commission; prescribing the membership and powers of the commission; and supplementing Title 26 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. The Legislature finds and declares that:
- a. Although the majority of Americans are covered by some
- 3 form of health insurance, families nevertheless lack protection
- 4 against the high cost of chronic or single episodes of serious ill-
- 5 ness that may destroy their resources. An illness resulting in this
- 6 potentially devastating financial consequence is referred to as a
- 7 catastrophic illness.
- 8 b. Catastrophic illnesses often threaten to push some families
- 9 into bankruptcy and others toward seeking inferior medical care
- 10 and present a major problem for this nation's health care system
- 11 in that catastrophic illnesses account for over 20% of this nation's
- 12 health expenditures.
- 13 c. The impact of catastrophic illnesses on the family is especially
- 14 acute in that children have the highest average medical costs among
- 15 the population as a whole.
- d. It is the public policy of this State that each child of this
- 17 State should have access to quality health care and adequate pro-
- 18 tection against the extraordinarily high costs of health care ser-
- 19 vices which are determined to be catastrophic and severely impact
- 20 upon a child and his family.

- e. To this end, it is incumbent upon the State to provide assis-

STATEMENT

This bill establishes the Catastrophic Illness in Children Relief Fund and the Catastrophic Illness in Children Relief Fund Commission, in but not of, the State Department of Health. The fund shall be administered by the commission and credited with monies from certain surcharges by insureds of health insurance collected under this bill. Providers of health insurance shall collect from insureds a \$1.00 surcharge per covered subscriber upon the premium paid for their health insurance policies. The surcharge shall be paid over to the State Treasurer for deposit in the fund.

The commission is comprised of: the Commissioners of Health, Human Services and Insurance, the State Treasurer and five public members, one of whom is a health care provider. The commission is directed to: establish the relief fund in conjunction with the existing Special Child Health Services program and administer the fund and authorize payment for medical expenses; establish procedures for enrolling in the program; establish the amount of reimbursement the fund will provide for medical services, based on a sliding fee scale, and adjust financial eligibility levels for participation in the program as the fund allows; and adopt necessary rules and regulations to carry out the program. The commission is required to report annually to the Governor and Legislature on the status of the fund.

Subject to certain rules and regulations established by the commission, children, through their parents or legal guardians, are eligible for financial assistance from the fund if they are residents of this State and have a catastrophic illness. A catastrophic illness is any illness the medical expenses whereof are not covered by any other State or federal assistance or any insurance contract and exceed 30% of the gross income of a family whose gross income is

\$100,000.00 or less per year or 40% of the gross income of a family whose gross income is over \$100,000.00 per year. The program shall provide financial reimbursement for the cost of medical treatment, hospital care, drugs, nursing care and physician services.

The Assembly Health and Human Resources Committee reports favorably Senate Bill No. 1550 OCR.

This bill establishes the "Catastrophic Illness in Children Relief Fund" in, but not of, the Department of Health, for the purpose of providing financial assistance to families of children with catastrophic illnesses. The bill defines a catastrophic illness as any illness or condition, the medical expenses of which are not covered by any other State or federal program or by private insurance and which exceed 30% of the income of a family whose annual income is \$100,000.00 or less, or 40% of the income of a family whose annual income is \$100,000.00 or more.

The bill imposes an annual \$1.00 surcharge per covered person upon all individual and group health insurance policies written in New Jersey pursuant to statutory law and upon all enrollees in health maintenance organizations authorized to operate in this State pursuant to statutory law. The moneys collected from this surcharge and the interest that those moneys earn shall be credited to the fund.

The bill provides that, in the case of an illness or condition for which a family, after receiving assistance from the Catastrophic Illness in Children Relief Fund, recovers damages for the child's medical expenses pursuant to a settlement or judgment in a legal action, the family shall reimburse the fund for the amount of assistance received, or for that portion of the amount of assistance which is covered by the amount of the damages minus the expense of recovery.

The bill also establishes a Catastrophic Illness in Children Relief Fund Commission in, but not of, the Department of Health, to administer the fund and authorize the payment or reimbursement of medical expenses from the fund, and to establish a program to accomplish the purposes of the fund in conjunction with the Special Child Health Services Program in the Department of Health. The commission shall disseminate information on the fund and the program to the public, establish procedures for enrolling in the program, develop a sliding fee

scale for the payment or reimbursement of medical expenses based upon a family's ability to pay, adjust financial eligibility criteria for the program based upon the amount of moneys available in the fund, and report annually to the Governor and the Senate Institutions, Health and Welfare Committee and General Assembly Health and Human Resources Committee on the status of the program.

The commission shall consist of nine members, including the Commissioners of Health, Human Services and Insurance and the State Treasurer, in addition to five public members appointed by the Governor who are residents of this State, two of whom shall be providers of health care services to children. One provider shall be appointed upon the recommendation of the President of the Senate and one upon the recommendation of the Speaker of the General Assembly.

This bill is identical to Assembly Bill No. 2315 Aca (Singer), which the committee also reported on this date.

The Senate Revenue, Finance and Appropriations Committee reported this bill favorably, with amendments.

As amended, this bill establishes the "Catastrophic Illness in Children Relief Fund" for the purpose of providing financial assistance for families of children with catastrophic illnesses. A catastrophic illness is defined in the bill as any illness or condition, the medical expenses of which are not covered by any other State or federal assistance program or any insurance contracts, and exceed 30% of the income of a family whose income is \$100,000.00 or less per year or 40% of the income of a family whose income is over \$100,000.00 per year.

The bill imposes an annual surcharge of \$1.00 per covered individual under health insurance policies, and per covered enrollee in a health maintenance organization. Monies collected from the surcharge are to be credited to the fund, along with interest earned on those monies.

The bill creates a nine-member Catastrophic Illness in Children Relief Commission, located in but not of the Department of Health, to administer the fund and establish a catastrophic illness relief program. Membership on the commission includes, ex officio, the Commissioners of Health, Human Services and Insurance and the State Treasurer; in addition, there are five public members appointed by the Governor, two of whom shall be health care providers.

As part of the relief program, the commission shall establish procedures for enrolling in the program; determine the amount of reimbursement for medical expenses, based on a sliding fee scale and taking into account family size, family income, assets, and medical expenses; and adjust financial eligibility criteria for participating in the program based upon the level of monies in the fund.

COMMITTEE AMENDMENTS:

The committee amendments: (1) require that all family income be considered in determining whether or not an illness is catastrophic, and in providing reimbursement; (2) clarify that "family" includes a child and his parent, parents, or legal guardian, as the case may be, who are

responsible for the child's medical expenses; (3) clarify that the \$1.00 insurance surcharge applies to all covered individuals in group or individual health insurance policies authorized under our statutory law, and to all enrollees of health maintenance organizations in the State; (4) provide for the reimbursement of the fund if a family recovers damages in the legal action for the child's illness or condition; and (5) delete certain unnecessary reporting requirements.

FISCAL IMPACT:

A fiscal note has not been prepared for this bill. On the basis of a preliminary analysis, however, it appears that the \$1.00 surcharge would raise approximately \$5,500,000.00 to \$6,000,000.00 per year. This analysis is based on the latest available health insurance industry estimates of covered individuals in the United States, and various estimates of the New Jersey share of those individuals.

During the last legislative session, the Department of Health estimated that a similar program proposed by Senate Bill No. 487 of 1984 would require approximately \$9,000,000.00 in funding for the first year. However, this committee estimated the cost at approximately \$5,000,000.00. The committee's estimate was based, in part, on the possible availability of other sources of assistance for certain families with catastrophically ill children, apart from the Catastrophic Illness in Children Relief Fund (e.g. the "medically needy" program).

Governor Thomas H. Kean today signed legislation establishing a "Catastrophic Illness in Children Relief Fund" to provide financial assistance to the families of children who are suffering from chronic or severe illnesses.

S-1550, sponsored by Senator Donald DiFrancesco, R-Union, Assemblyman Robert Singer, R-Ocean and Assemblywoman Maureen Ogden, R-Essex, defines "catastrophic illness" as any illness or condition whose medical expenses are not covered by any other State or Federal program or insurance contract and exceed 30 percent of the income of family whose income is \$100,000 or less, or 40 percent of the income when the family income is over \$100,000.

The fund will be a non-lapsing revolving fund which will receive the money collected from a \$1 annual surcharge for each employee paid by employers who are subject to the New Jersey Unemployment Compensation Law. The surcharge is expected to raise \$3.9 million annually.

The fund will be administered by the Children Relief Fund Commission whose members will include the Commissioners of Health, Human Services, Insurance, the State Treasurer and five public members.

The legislation is effective immediately.
