The Assembly Judiciary Committee reports favorably and with committee amendments Assembly Bill No. 1155.

This bill provides that victims of cosmetic, drug or food product tampering may petition the Violent Crimes Compensation Board for damages resulting from personal injury or death.

The committee amended the bill to include an appropriation of \$66,000.00 to the board to cover initial costs that would be incurred under the bill.

Another amendment makes this bill inoperative until enactment into law of Assembly Bill No. 1156, a companion bill.

This bill was pre-filed for introduction in the 1986 session pending technical review. As reported and amended, the bill includes the changes required by technical review which has been performed.

The Senate Judiciary Committee reports favorably Assembly Bill No. 1155 OCR.

Presently, victims of certain enumerated offenses may petition the Violent Crimes Compensation Board for compensation if injuries or death result from those offenses. This bill would include tampering with a cosmetic, drug or food product as an offense for which damages may be compensated by the VCCB. The bill would appropriate \$66,000.00 to the VCCB to cover the initial costs necessary to implement its provisions.
