### STATEMENT

This bill would provide that ballots for school elections shall not be declared invalid because the marks made with ink or lead pencil appear to be other than black. The purpose of this bill is to conform the school elections law to the general elections law (R. S. 19:16-4) and void the invalidation of ballots merely because voters may use any color ink or lead pencil by mistake.

## STATE OF NEW JERSEY

DATED: MARCH 6, 1986

The Senate Education Committee favorably reports Senate Bill No. 295.

This bill provides that school election ballots shall not be declared invalid because the marks made with ink or lead pencil are not black. N. J. S. 18A:14-55 requires that school election ballots be marked in black and provides no exception to permit the counting of ballots marked in a color other than black.

General elections law also requires black ink or lead (R. S. 19:15–27 and R. S. 19:15–28), but provides that use of a color other than black is not grounds to invalidate a ballot (R. S. 19:16–4). This bill would conform the school elections law to the general elections law.

This bill was pre-filed for introduction in the 1986 session pending technical review. As reported the bill includes the changes required by technical review which has been performed.

This bill is identical to Assembly Bill No. 184 (Haytaian) which has been released by the Assembly Education Committee and is currently on second reading in the Assembly.
