The Senate Education Committee favorably reports this bill.

This bill establishes the Raoul Wallenberg Visiting Professorship in Human Rights in the Department of History at Rutgers University. The university is to select an outstanding individual to fill the professorship whose scholarship, teaching and public service reflect the humanitarian ideals of Raoul Wallenberg. The bill stipulates that no person may fill the professorship for longer than 24 months. The bill appropriates \$100,000 to fund the visiting professorship.

BACKGROUND:

- 1. Raoul Wallenberg is a Swedish citizen whose heroic and selfless actions during World War II resulted in saving the lives of over 100,000 Jewish residents of Hungary. In recognition of his heroism and commitment to human rights, Raoul Wallenberg was granted honorary United States citizenship on October 5, 1981.
- 2. A similar bill was introduced into the 1984-85 legislative session. It passed both the Senate and General Assembly without opposition but was not signed by Governor Kean because the bill did not place the professorship within a particular academic department. The Governor indicated that he would approve legislation which places the professorship within the Department of History at Rutgers.
- 3. The Legislature has established a number of scholarly chairs at colleges and universities throughout the State which have been named for distinguished individuals. These include the Albert Einstein Chair for Scholarly Studies at the Institute for Advanced Study, the Richard J. Hughes Chair for Constitutional and Public Law at Seton Hall University, the Alfred E. Driscoll Chair in Pharmaceutical/Chemical Studies at Fairleigh Dickinson University, the Women's Studes Chair at Douglass College and the Will and Ariel Durant Chair in Humanities at Saint Peter's College.

In the Governor's proposed budget for FY 1987 each of these chairs is funded at \$65,000.00 except for the Women's Studies Chair which is funded at \$75,000.

This bill is identical to Assembly Bill No. 1875 which was released by the Assembly Higher Education Committee on February 13 and which is now in the Assembly Revenue Committee.

Governor Thomas H. Kean today signed legislation establishing the Raoul Wallenberg Visiting Professorship in Human Rights at Rutgers University.

Raoul Wallenberg was a Swedish citizen whose heroic and humanitarian deeds during World War II resulted in the saving of 100,000 lives of Jewish residents of Hungary and thousands of other persons as well.

The legislation, <u>S-1553</u>, sponsored by Senator Laurence Weiss, D-Middlesex, and Assemblywoman Dolores Cooper, R-Atlantic appropriates \$100,000 to establish the visiting professorship chair in the History Department of Rutgers.

Referring to Wallenberg's role in saving hundreds of thousands from Nazi persecution, Governor Kean said, "I want my children and everyone's children to study Raoul Wallenberg's life, just as I want them to learn about the Holocaust and its reality. I want them to learn that no matter how terrible the evil in this world, it can always be confronted by good. SENATE BILL NO. 3249

STATEMENT

I am filing Senate Bill No. 3249 in the Division of Archives and Records Management without my approval.

Under the provisions of Article V, Section I, Paragraph 14 of the Constitution, this bill, which was passed within 10 days preceding the expiration of the second legislative year, does not become law because it was not signed prior to the seventh day following such expiration. In this circumstance, there is no provision for a veto, but I deem it to be in the public interest to state my reasons for deciding not to sign this bill.

This bill would create the Raoul Wallenberg Visiting Professorship in Human Rights at Rutgers. It provides a \$100,000 appropriation to support the first year of the professorship.

Raoul Wallenberg was a man among men during heinous times. The Swedish citizen's heroic and selfless actions during World War II, resulted in saving the lives of over 100,000 Jews residing in Hungary.

I support the creation of a Professorship in honor of Raoul Wallenberg but

I am concerned that this legislation would provide one not affiliated with a

particular department or field of academic study. I commend the sponsor for

his commitment to this great humanitarian and recommend that there be a designation

of a Raoul Wallenberg Professorship at Rutgers within the Department of History.

I will sign legislation which reaches my desk which meets this criteria.

Accordingly, I must file Senate Bill No. 3249 without my approval.
