An Acr concerning motor vehicles retired from use as school buses and supplementing Chapter 8 of Title 39 of the Revised Statutes.

1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1 1. A motor vehicle retired from use as a school bus as defined 2 in R. S. 39:1-1 which is used to transport children *[and]* *or* senior citizens to entertainment programs, recreational areas, sporting 3 4 events, or camping activities shall not be used for those purposes 5 unless the motor vehicle has met the safety regulations for school 6 buses dealing with mechanical condition and body integrity adopted in accordance with the "Administrative Procedure Act," 7 8 P. L. 1968, c. 410 (C. 52:14B-1 et seq.) by the Department of Edu-9 cation, with the exception of school bus chrome yellow color and 10 amber and red warning lamp system regulations. No motor vehicle 11 retired from use as a school bus shall be required to meet the 12 safety regulations for school buses adopted by the Department of 13 Education other than those in effect for the class of vehicle of 14 which the bus was a member on the date upon which the vehicle was last inspected prior to its retirement as a school bus. 15

1 2. This act shall take effect immediately.

MOTOR VEHICLE-GENERAL

Requires that retired school buses used to transport children or senior citizens to certain events and programs meet school bus safety regulations dealing with mechanical condition and body integrity.

This bill provides that a school bus retired from service which is used to transport children and senior citizens to entertainment programs, recreational areas, sporting events or camping activities shall meet certain safety regulations for school buses adopted by the Department of Education. An exception is provided from the regulations requiring school buses to be chrome yellow in color and requiring them to have an amber and red warning lamp system.

The Assembly Transportation, Communications and High Technology Committee reports favorably Senate Bill No. 136 with a committee amendment.

This bill provides that a school bus retired from service which is used to transport children or senior citizens to entertainment programs, recreational areas, sporting events or camping activities shall meet all safety regulations for school buses adopted by the Department of Education which deal with the mechanical condition and body integrity of the vehicle. The bill also specifically exempts the retired school buses from being required to be chrome yellow in color or to have an amber and red warning lamp system. In addition, this legislation provides that a retired school bus shall not be required to meet a more stringent safety standard than that imposed in regard to the class of which it was a member when it was last inspected prior to its retirement.

The committee amended the bill so as to clarify the point that its provisions are to apply in cases when either children or senior citizens are transported on retired school buses to entertainment programs, recreational areas, sporting events or camping activities.

The Department of Education has established regulations for the retirement of school buses. Most school buses manufactured prior to April 1, 1977, are retired from use for transporting students after ten years of service. As regards school buses manufactured after April 1, 1977, those whose gross vehicle weight is 25,000 pounds or less shall not be utilized for pupil transportation purposes beyond twelve years and those whose gross vehicle weight exceeds 25,000 pounds shall not be utilized for pupil transportation purposes beyond the twentieth year from the date of manufacture.

The Senate Transportation and Communications Committee favorably reports Senate Bill No. 136.

This bill provides that a school bus retired from service which is used to transport children and senior citizens to entertainment programs, recreational areas, sporting events or camping activities shall meet all the safety regulations for school buses adopted by the Department of Education which deal with the mechanical condition and body integrity of the vehicle. The bill also specifically exempts the retired school buses from being required to be chrome yellow in color or to have an amber and red warning lamp system. In addition, this legislation provides that a retired school bus shall not be required to meet a more stringent safety standard then that imposed in regard to the class of which it was a member when it was last inspected prior to its retirement.

This bill was pre-filed for introduction in the 1986 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.
