PRE-FILED FOR INTRODUCTION IN THE 1986 SESSION

By Senator DUMONT

AN ACT concerning the "Municipal Court Administration Reimbursement Fund" and amending P. L. 1983, c. 531.

1	Be it enacted by the Senate and General Assembly of the State
2	of New Jersey:
1	1. Section 6 of P. L. 1983, c. 531 (C. 26:2B-35) is amended to

- (2) The Administrative Office of the Courts shall certify the amounts submitted by each municipality and shall calculate for each municipality any increase in the number of arrests between the base year and the number of arrests reported for the preceding calendar year. The Administrative Office of the Courts shall then calculate the sum of all increases for all municipalities reporting.
- (3) Beginning for calendar year 1983, the following fraction shall be calculated for each municipality:

The increase in drunk driving arrests in the municipality between the base year and the preceding year over the total of increases in drunk driving arrests between the base year and the preceding year in all reporting municipalities in the State.

This fraction shall be multiplied by the total amount of the money available in the "Municipal Court Administration Reimbursement **4**0 Fund" in the preceding calendar year. This amount shall be allo-42 cated to the municipality for the purpose of maintaining its municipal court which may include payments to municipal court judges, 43 municipal prosecutors and other municipal court personnel for 44 work performed in addition to regular employment hours.

2. This act shall take effect immediately and shall apply to 1 amounts allocated from the "Municipal Court Administration Reimbursement Fund" to municipalities in 1985. 3

STATEMENT

This bill permits a municipality to use a substituted base year figure for the purpose of calculating the municipality's share of the money available in the "Municipal Court Administration Reimbursement Fund".

A municipality may substitute the average number of drunk driving arrests made in 1979 and 1981 as the base figure rather than the number made in 1980. This provision makes the allotment more equitable for municipalities in which calendar year 1980 arrests were disproportionate to the years preceding and following. Once the substituted base figure is used, it may not be changed but will remain the base figure for all future calculations.

The Assembly Law, Public Safety, Defense and Corrections Committee favorably reports Senate Bill No. 817.

In 1984, P. L. 1983, c. 531 (C. 26:2B-32 et seq.) created the Alcohol Education, Rehabilitation, and Enforcement Fund. One third of the money dedicated for enforcement from this fund is distributed through the Municipal Court Administration Fund which allocates money to each municipality pursuant to a formula based on the increase in drunk driving arrests in that municipality. The base year for this formula is set by statute at 1980.

This bill would permit a municipality in which the average number of drunk driving arrests for 1979 and 1981 was less than the number for 1980 to substitute the lower figure for the calculations to be made under the Municipal Court Administration Fund. A municipality which wants to use the substituted base year would have to notify the Administrative Office of the Courts within 90 days of the bill's enactment into law.

The Senate Judiciary Committee reports favorably Senate Bill No. 817.

P. L. 1983, c. 531 created the Alcohol Education Rehabilitation and Enforcement Fund. One-third of the moneys dedicated for enforcement from this fund are to be distributed through the "Municipal Court Administration Fund" which allocates money to each municipality pursuant to a formula which is based on an increase in drunk driving arrests in the municipality.

The base year for this formula is 1980. The designation of 1980 as the base year has worked to the disadvantage of Phillipsburg, a municipality in the sponsor's district. In 1980, there were 209 arrests for drunk driving in Phillipsburg as compared to 110 in 1979 and 93 in 1981. The abnormally large number of arrests in 1980 is attributable to the fact that a State Police Tact Team worked in Phillipsburg during 1980.

In order to address this situation, this bill would permit a municipality whose drunk driving arrests for 1979 and 1981 average less than the number of 1980 arrests to substitute the lower average figure as its base number for purposes of allocation under the "Municipal Court Administration Fund." If a municipality wishes to use a substitute figure, it must certify that figure to the Administrative Office of the Courts within 90 days of the bill's enactment.

This bill was pre-filed for introduction in the 1986 session pending technical review. As reported the bill includes the changes required by technical review which has been performed.
