The Assembly Energy and Natural Resources Committee favorably reports Senate Bill No. 2247.

The purpose of this bill is to authorize the sterilization of dogs and cats adopted from nonprofit animal shelters and municipal, county, or regional pounds and licensed pursuant to State or municipal law to be supported in part by monies in the Animal Population Control Fund created pursuant to P. L. 1983, c. 172 under the Animal Population Control Program established therein. The bill thus removes a disincentive to the adoption of homeless animals while helping to reduce the future population of such animals.

The bill would not require additional funding. Revenues are to be drawn from monies in the fund and the \$20.00 copay from persons adopting dogs. Further, applications of fund monies to this purpose is conditioned upon the availability of sufficient funds.

The Senate Natural Resources and Agriculture Committee favorably reported Senate Bill No. 2247.

This bill would extend eligibility for participation in the Animal Population Control Program, which now provides low-cost sterilization services to owners of dogs or cats who meet certain criteria of need, to owners who have adopted pets from non-profit animal shelters and pounds and pay a \$20.00 fee. Owners must also show that the dog or cat is duly licensed pursuant to State and municipal law where required. The extension of eligibility is not expected to require additional funding because revenues will be made available from monies currently in the Animal Population Control Fund and the \$20.00 copay from persons adopting pets.
