4 **BE IT ENACTED** by the Senate and General Assembly of the State

9 b. The <sup>1</sup>commercial<sup>1</sup> operator of any snowplow, or other snow  
10 removal equipment, clearing accumulated snow on private property  
11 shall not deposit, or cause to be deposited, such snow on any public  
12 road, street, or highway in this State or on public lands. **[An] A**  
13 commercial<sup>1</sup> operator of any snowplow or other snow removal  
14 equipment who fails to comply with the provisions of this section  
15 shall be liable to a fine of \$250 for the first offense, and for each  
16 subsequent offense, a fine of \$500.

The Assembly Transportation, Public Works and Independent Authorities Committee reports favorably and with committee amendments Senate Bill No. 1924.

As reported, this amended bill, known as the “Anti-Snow Dumping Act,” would prohibit commercial snowplow operators, or the commercial operator of any other snow removal equipment, clearing accumulated snow on private property from depositing, or causing to be deposited, such snow on any public road, street, or highway in this State or on public lands. A commercial operator of any snowplow or other snow removal equipment who fails to comply with the provisions of this bill is liable to a fine of \$250 for the first offense, and \$500 for each subsequent offense.

Senate Bill No. 1924, as amended and reported, is identical to Assembly Bill No. 3577, which was amended and reported by the committee on this date.

COMMITTEE AMENDMENTS

The committee amended the bill to provide that the provisions of the bill shall only apply to a commercial operator of a snowplow or other snow removal equipment.

As reported, this amended bill, known as the “Anti-Snow Dumping Act,” would prohibit commercial snowplow operators, or the commercial operator of any other snow removal equipment, clearing accumulated snow on private property from depositing, or causing to be deposited, such snow on any public road, street, or highway in this State or on public lands. A commercial operator of any snowplow or other snow removal equipment who fails to comply with the provisions of this bill is liable to a fine of \$250 for the first offense, and \$500 for each subsequent offense.

Assembly Bill No. 3577, as amended and reported, is identical to Senate Bill No. 1924, which was amended and reported by the committee on this date.

COMMITTEE AMENDMENTS

The committee amended the bill to provide that the provisions of the bill shall only apply to a commercial operator of a snowplow or other snow removal equipment.
