# **BILL DESCRIPTION**

Senate Bill No. 376 of 2012 requires the Department of the Treasury to prepare materials on organ and tissue donation jointly with federally-designated organ procurement organizations for New Jersey. The department is to distribute the information with employee paychecks during each month of April and to make it available to State contractors so that they may voluntarily disseminate the information to their employees. The bill takes effect 90 days after the date of enactment.

### FISCAL ANALYSIS

#### **EXECUTIVE BRANCH**

The Office of Management and Budget in the Department of the Treasury relates that the State cost of the bill will depend on the specific media employed to disseminate organ and tissue donation information to State employees. The bill will have a minimal State cost if the Treasury distributes the information through electronic means or a written statement directly printed on employee pay stubs. But if the information is provided as a separate brochure, the State will incur indeterminate printing and distribution costs. In general, the Office of Management and Budget points out that there has been an effort to avoid pay stub inserts due to their cost.

#### **OFFICE OF LEGISLATIVE SERVICES**

The OLS concurs with the Executive estimate and notes that the bill will first produce a cost to the State General Fund in fiscal year 2013. This will be so because the information has to be disseminated in April of each year. The bill, however, takes effect 90 days after the date of enactment, which will be subsequent to April 2012.

Although the OLS is not privy to information on the costs the Department of the Treasury incurs in printing and distributing brochures to State employees, for illustrative purposes, it can indicate approximate printing costs if the brochures were to be printed in an outside print shop. Any cost of distribution would be extra and the example does not consider the cost of printing additional brochures for distribution to employees of State vendors, as the bill only encourages, but does not require, State vendors to inform their employees of organ and tissue donation options.

The Office of the State Auditor reported in its July 2011 audit report on the Office of Management and Budget that the latter processed the regular State payroll for 80,000 employees. UPrinting.com offers to print 80,000 letter-sized, tri-fold, paper gloss, color brochures printed on both sides for \$5,300 including shipping, as of February 24, 2012. Without shipping, the printing of 80,000 brochures would cost \$4,113. FedEx, on the other hand, offers to print 5,000 tri-fold brochures in full-color on both sides for \$880 including shipping, as of February 24, 2012. Assuming that there would not be an additional volume discount, printing 80,000 brochures would thus cost \$14,080 at FedEx.

## Governor Christie Signs Legislation to Raise Awareness of the Importance of Lifesaving Organ Donation

Legislation Designates April as Donate Life Month in New Jersey

**Trenton, NJ –** Acting to create greater public awareness about the lifesaving importance of organ donation, Governor Chris Christie today signed A-1265 establishing April as Donate Life Month in New Jersey. The legislation, signed following a tour of Newark Beth Israel Medical Center, requires that the State disseminate organ and tissue donation information to all State employees during the month of April, reminding them of the need for organ donors. Additionally, this law directs the Department of Treasury to encourage all businesses with contracts with the State to notify their employees of organ donation options through information and materials or through an awareness program.

"Establishing Donate Life Month is an opportunity for all residents to learn more about the critical importance of registering to become an organ donor," said Governor Christie. "By going through the simple process of becoming an organ donor, just one person can make a difference in as many as 50 lives. With nearly 5,000 New Jersey residents waiting to receive a life-saving organ transplant, being an organ donor is one of the most profound gifts to give someone else – a chance at a new, healthy life. And the gift of life is truly the greatest gift of all."

Nationally, there are more than 111,000 people waiting to receive a life-saving organ transplant. Every 10 minutes another name is added to the waiting list.

"I am extremely pleased to have the Governor and Health and Senior Services Commissioner Mary O'Dowd visit Newark Beth Israel Medical Center to highlight the importance of organ donation and the life-saving clinical success of our transplant program," said Barry H. Ostrowsky, President and CEO of Barnabas Health.

While New Jersey is making strides in organ donation, the state ranks 41 out of 50 states, with only 31% of residents registered organ and tissue donors.

"The need for organ transplants and the shortage of donors affects people of all ethnic backgrounds. Currently, more than half of the 5,000 people waiting for a life-saving organ transplant are minorities," said Health and Senior Services Commissioner Mary E. O'Dowd. "As we celebrate Minority Health Month in New Jersey, it is important to recognize the need to increase the diversity of registered donors. Those waiting for a life-saving organ are more likely to receive transplants if more people from all backgrounds donate."

Anyone, regardless of age or medical history, can sign up to be a donor. Organ donor registration is available online or in-person at local Motor Vehicle Commission agencies. Residents can request a paper registration form at 1.800.742.7365. When registering in-person, the words "Organ Donor" will appear on the NJ driver license or non-driver identification card. When registering online or through paper registration, the designation will appear in the driver's record. Saying "yes" to organ donation is legal consent to the donation of organs and tissue for the purpose of transplantation or medical research.
