The Assembly Local Government Committee reports favorably Assembly Bill No. 2111.

This bill amends the "Structured Financing Act," P.L.1999, c.157 (C.52:31C-1 et seq.) to permit regional, county and municipal sewerage and utility authorities to participate in structured financing agreements. When the original law was enacted in 1999 it applied to State government, counties, municipalities and school districts.

A structured financing agreement is a new and innovative financing technique. Some government entities own large inventories of real and tangible personal property assets. These assets often are associated with certain benefits that have value to private sector parties but that have no value to a government entity. A government entity can obtain additional revenue by transferring the assets and their associated benefits to a party that can make use of the benefits, and then taking back just the asset. Such transactions include tax-oriented lease/leaseback arrangements.

The Senate Community and Urban Affairs Committee reports favorably and with committee amendments Assembly Bill No. 2111.

As amended by the committee, this bill would amend the "Structured Financing Act," P.L.1999, c.157 (C.52:31C-1 et seq.) to direct the State Treasurer to establish procedures under which sewerage authorities created pursuant to the "sewerage authorities law," P.L.1946, c.138 (C.40:14A-1 et seq.), utilities authorities created pursuant to the "municipal and county utilities authorities law," P.L.1957, c.183 (C.40:14B-1 et seq.) and the Passaic Valley Sewerage Commissioners may undertake structured financing agreements. When the original law was enacted in 1999 it applied to State government, counties, municipalities and school districts.

The committee amended the bill to authorize the Passaic Valley Sewerage Commissioners to undertake structured financing agreements and to correctly reference the "sewerage authorities law," P.L.1946, c.138 (C.40:14A-1 et seq.), and the "municipal and county utilities authorities law," P.L.1957, c.183 (C.40:14B-1 et seq.).

This bill as amended by the committee is identical to Senate Bill No. 1196 with committee amendments also reported by the committee on May 22, 2000.

CHAPTER 54
