The Assembly Education Committee favorably reports Assembly Bill No. 1762.

Under current law the board of education in each school district in the State in which a nonpublic school is located has the power and duty to purchase and to loan textbooks to all students attending the nonpublic school. This bill would expand the definition of "textbook" to include electronic textbooks including, but not limited to, computer software, computer-assisted instruction, interactive videodisk, and other computer courseware and magnetic media.

This bill was pre-filed for introduction in the 2000 session pending technical review. As reported, the bill includes the changes required by technical review, which has been performed.

BILL DESCRIPTION

Assembly Bill No. 1762 of 2000 would expand the definition of "textbook" to include electronic texbooks, including but not limited to, computer software, computer-assisted instruction, interactive videodisk, and other computer courseware and magnetic media. Under current law the board of education in each school district in the State in which a nonpublic school is located has the power and duty to purchase and to loan textbooks to all students attending the nonpublic school.

OFFICE OF LEGISLATIVE SERVICES

The Office of Legislative Services notes that this bill will not impose any additional funding requirements on the State, but rather expands the types of instructional materials on which aid currently received under the nonpublic textbook aid program may be expended. P.L.1974, c.79 (C.18A:58-37.1 et seq.) provides that the per pupil amount of nonpublic textbook aid in any budget year shall not exceed the State average public school per pupil amount budgeted for textbooks in the prebudget year. In FY 2000, \$8,973,000 is appropriated for the nonpublic textbook aid program, which represents \$44.74 per nonpublic school pupil. According to the Department of Education, this represents a prorated amount of the approximately \$60 per pupil which is authorized under the formula contained in P.L.1974, c.79 (C.18A:58-37.1 et seq.). A-1762 simply provides that any funds appropriated pursuant to P.L.1974, c.79 (C.18A:58-37.1 et seq.) may be spent on electronic instructional materials in addition to traditional textbooks. The bill therefore does not require any additional State or local funds.

CHAPTER 13

AN ACT concerning State aid to pupils in nonpublic schools and amending P.L.1974, c.79.

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

"Textbook" means books, workbooks or manuals, whether bound or in looseleaf form, or electronic textbooks, including but not limited to, computer software, computer-assisted instruction, interactive videodisk, and other computer courseware and magnetic media, intended as a principal source of study material for a given class or group of students, a copy of which is available for the individual use of each pupil in such class or group. Computer software shall be prepared educational programs which are subject- oriented and for student instruction.

d. "Student" means any child who is a resident of the State and who is enrolled as a full-time pupil in a public or nonpublic school in grades kindergarten through 12. A child who boards at a school but whose parents do not maintain a residence in this State shall not be deemed to be a resident of the State within the meaning of this act.

Gov. Christie Whitman today signed the following piece of legislation:

A-1762, sponsored by Assembly Member David W. Wolfe (R-Monmouth/Ocean) and Senators Joseph A. Palaia (R-Monmouth) and Diane B.
