The Senate Women's Issues, Children and Family Services Committee reports favorably Senate Bill No. 175.

This bill directs the Commissioner of Human Services to establish certain staffing level ratios for Division of Youth and Family Services (DYFS) caseworkers which shall not exceed Child Welfare League of America standards. Each DYFS district office would be required to maintain a ratio of 25 cases to one caseworker for a generic caseload and 12 to one for an intake or high risk caseload. Additionally, each DYFS adoption resource center would be required to maintain a ratio of 15.5 cases to one caseworker.

If these staffing level ratios exceed 10 percent for two consecutive quarters, the division would be required to hire additional caseworkers, irrespective of any hiring freeze imposed by the State on Department of Human Services or DYFS personnel.

The bill also appropriates \$12,000,000 to the Department of Human Services to hire the 400 additional caseworkers needed by DYFS to meet the staffing level ratios proposed by the provisions of the bill.

This bill is identical to Assembly Committee Substitute for Assembly Bill Nos. 2104 and 766 (Cotrell/LeFevere/Previte/O'Toole) which is currently pending before the Assembly Appropriations Committee.

This bill was prefiled for introduction in the 2000-2001 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.

The Senate Budget and Appropriations Committee reports favorably Senate Bill No. 175.

This bill directs the Commissioner of Human Services to establish certain specified staffing level ratios for Division of Youth and Family Services (DYFS) caseworkers in the division's district offices and adoption resource centers.

The casework functions performed in the division's 32 district offices include receiving allegations of child abuse or neglect; conducting initial protective service investigations of those allegations; placing children in foster care; performing protective services case management and supervision; and providing family support, prevention and reunification services. Casework responsibilities of DYFS's five adoption resource centers (ARC's) include termination of parental rights, review of applications by those seeking to become adoptive parents, placement of children for adoption, monitoring of those placements, and providing support services to adoptive families.

Under the bill:

(1) The ratio of cases per caseworker in a division district office could not exceed Child Welfare League of America standards, or 25:1 for a generic caseload and 12:1 for an intake or high risk caseload; and

(2) The ratio of cases per caseworker in an adoption resource center or division-funded adoption program could not exceed $15\frac{1}{2}$:1.

If these staffing level ratios are exceeded by 10% for two consecutive quarters, DYFS would be required to hire additional caseworkers to maintain the ratios, irrespective of any hiring freeze imposed by the State on Department of Human Services or DYFS personnel.

FISCAL IMPACT

The bill appropriates from the General Fund to the Department of Human Services the sum of \$12,000,000 to effectuate the purposes of the legislation. This amount would be used to hire the 400 additional DYFS caseworkers believed necessary to meet the staffing level ratios proposed under the bill.

The Assembly Appropriations Committee reports favorably Senate Bill No. 175 with committee amendments.

Senate Bill No. 175, as amended, directs the Commissioner of Human Services to establish certain staffing level ratios for Division of Youth and Family Services (DYFS) caseworkers which shall not exceed Child Welfare League of America standards. Each DYFS district office would be required to maintain a ratio of 25 cases to one caseworker for a generic caseload and 12 to one for an intake or high risk caseload. Additionally, each DYFS adoption resource center would be required to maintain a ratio of 15.5 cases to one caseworker. If these staffing level ratios exceed 10% for two consecutive quarters, the division would be required to hire additional caseworkers, irrespective of any hiring freeze imposed by the State on Department of Human Services or DYFS personnel.

The bill requires that the commissioner phase in the staffing level ratios over a three fiscal year period by incrementally increasing the caseworker staff so that the staff levels are achieved by the end of the three year period. Research has failed to reveal that any state youth services agency currently maintains staffing levels at the Child Welfare League of America standards, and the incremental phase-in will allow less abrupt demands on hiring and training resources.

The bill requires the Commissioner of Human Services to make annual report to the Legislature concerning the status of caseworker staff phase-in and the progress of the Division of Youth and Family Services in achieving the staffing level ratio targets. The report shall note the effectiveness of the staffing level phase- in changes and include recommendations of the commissioner for improving division services.

As amended and reported, this bill is identical to Assembly Bill Nos. 2104 and 766 ACS as also amended and reported.

FISCAL IMPACT:

The bill also appropriates \$12,000,000 to the Department of Human Services to hire the 400 additional caseworkers needed by

DYFS to meet the staffing level ratios proposed by the provisions of the bill.

COMMITTEE AMENDMENTS:

The amendments provide for the three year phase-in period for achieving the required staffing level ratios, delete a provision that would have deferred the effective date of the requirements for one year to provide for a transition, and provide for the annual reports by the commissioner to the Legislature.

The Office of Legislative Services (OLS) **concurs** with the Executive Estimate, however, the department's gross costs in the first year would be reduced by the \$12 million appropriation provided by the bill and the \$6.0 million appropriated in the FY 2001 State Budget for additional staffing and support hiring.
- ! As the number of cases assigned to adoption resource centers and the number of cases considered "generic" and "intake or high risk" are not known, the staffing estimates and related costs cannot be verified. Thus, costs may be greater or lower than indicated, depending on the number of cases assigned to adoption resource centers and the number of cases classified as "generic" and "intake or high risk."
- ! Costs may be reduced by requiring a higher clerical support ratio than the 1:5.5 clerical support person to social work staff ratio the estimates assume.
- ! Estimates of federal reimbursement are uncertain. Until claims are submitted to the federal government, the amount of federal reimbursement received will not be known.

An additional 805 personnel would have to be employed: 681 social work staff and 124 support personnel. In the first year, approximately 68 percent of program costs would be used for personnel related costs; in subsequent years, approximately 85 percent of program costs would be for personnel related costs as certain one-time costs incurred in the first year are no longer required. No data are provided as to the number of cases assigned to the adoption resource centers or the number of cases considered "generic" or "intake or high risk."

OFFICE OF LEGISLATIVE SERVICES

The Office of Legislative Services concurs with the Executive Estimate, however, the department's gross costs in the first year would be reduced by the \$12 million appropriation provided by the bill and the \$6.0 million appropriated in the FY 2001 State Budget for additional staffing and support hiring. However, there are many unknown variables which will affect the legislation's cost:

- C DHS and OMB estimates do not indicate the number of cases in adoption resource centers or the number of cases considered "generic" or "intake or high risk." Without knowing the caseload breakdown, the estimate that 681 social work staff will be required cannot be verified.
- ^C The estimates assume that one clerical support person would be required for every 5.5 social work staff persons. As there is no standard for clerical support personnel, costs can be reduced by assuming a different clerical support personnel ratio.
- ^C Estimates of federal funds are speculative because until claims are submitted, reviewed and approved by the federal government, the amount of federal reimbursement the State will receive is uncertain. State costs will increase or decrease, depending on the actual amount of federal funding the State receives.

The Assembly Senior Issues and Community Services Committee reports favorably Assembly Committee Substitute for Assembly Bill Nos. 2104 and 766.

This bill directs the Commissioner of Human Services to establish certain staffing level ratios for Division of Youth and Family Services (DYFS) caseworkers which shall not exceed Child Welfare League of America standards. Each DYFS district office would be required to maintain a ratio of 25 cases to one caseworker for a generic caseload and 12 to one for an intake or high risk caseload. Additionally, each DYFS adoption resource center would be required to maintain a ratio of 15.5 cases to one caseworker.

If these staffing level ratios exceed 10% for two consecutive quarters, the division would be required to hire additional caseworkers, irrespective of any hiring freeze imposed by the State on Department of Human Services or DYFS personnel.

The bill also appropriates \$12,000,000 to the Department of Human Services to hire the 400 additional caseworkers needed by DYFS to meet the staffing level ratios proposed by the provisions of the bill.

The Assembly Appropriations Committee reports favorably Assembly Bill Nos. 2104 and 766 (ACS) with committee amendments. Assembly Bill Nos. 2104 and 766 ACS, as amended, directs the Commissioner of Human Services to establish certain staffing level ratios for Division of Youth and Family Services (DYFS) caseworkers which shall not exceed Child Welfare League of America standards. Each DYFS district office would be required to maintain a ratio of 25 cases to one caseworker for a generic caseload and 12 to one for an intake or high risk caseload. Additionally, each DYFS adoption resource center would be required to maintain a ratio of 15.5 cases to one caseworker. If these staffing level ratios exceed 10% for two consecutive quarters, the division would be required to hire additional caseworkers, irrespective of any hiring freeze imposed by the State on Department of Human Services or DYFS personnel.

The bill requires that the commissioner phase in the staffing level ratios over a three fiscal year period by incrementally increasing the caseworker staff so that the staff levels are achieved by the end of the three year period. Research has failed to reveal that any state youth services agency currently maintains staffing levels at the Child Welfare League of America standards, and the incremental phase-in will allow less abrupt demands on hiring and training resources.

The bill requires the Commissioner of Human Services to make annual report to the Legislature concerning the status of caseworker staff phase-in and the progress of the Division of Youth and Family Services in achieving the staffing level ratio targets. The report shall note the effectiveness of the staffing level phase- in changes and include recommendations of the commissioner for improving division services.

As amended and reported, this bill is identical to Senate Bill No 175 as also amended and reported.

FISCAL IMPACT:

The bill also appropriates \$12,000,000 to the Department of Human Services to hire the 400 additional caseworkers needed by DYFS to meet the staffing level ratios proposed by the provisions of the bill.

COMMITTEE AMENDMENTS:

The amendments provide for the three year phase-in period for achieving the required staffing level ratios, delete a provision that would have deferred the effective date of the requirements for one year to provide for a transition, and provide for the annual reports by the commissioner to the Legislature.

An additional 805 personnel would have to be employed: 681 social work staff and 124 support personnel. In the first year, approximately 68 percent of program costs would be used for personnel related costs; in subsequent years, approximately 85 percent of program costs would be for personnel related costs as certain one-time costs incurred in the first year are no longer required. No data are provided as to the number of cases assigned to the adoption resource centers or the number of cases considered "generic" or "intake or high risk."

OFFICE OF LEGISLATIVE SERVICES

The Office of Legislative Services concurs with the Executive Estimate, however, the department's gross costs in the first year would be reduced by the \$12 million appropriation provided by the bill and the \$6.0 million appropriated in the FY 2001 State Budget for additional staffing and support hiring. However, there are many unknown variables which will affect the legislation's cost:

- C DHS and OMB estimates do not indicate the number of cases in adoption resource centers or the number of cases considered "generic" or "intake or high risk." Without knowing the caseload breakdown, the estimate that 681 social work staff will be required cannot be verified.
- ^C The estimates assume that one clerical support person would be required for every 5.5 social work staff persons. As there is no standard for clerical support personnel, costs can be reduced by assuming a different clerical support personnel ratio.

C Estimates of federal funds are speculative because until claims are submitted, reviewed and approved by the federal government, the amount of federal reimbursement the State will receive is uncertain. State costs will increase or decrease, depending on the actual amount of federal funding the State receives.

Pursuant to Article V, Section I, Paragraph 15 of the New Jersey Constitution, I am appending to Assembly Substitute for Senate Bill No. 175 and Assembly Committee Substitute for Assembly Bill Nos. 2104 and 766, at the time of my signing it, my statement of items, or parts thereof, to which I object so that each item, or part thereof, so objected to shall not take effect.

This bill establishes a Staffing and Outcome Review Panel in, but not of, the Department of Human Services' Division of Youth and Family Services (DYFS). The Review Panel will be required to review DYFS' current staffing levels and develop recommendations regarding appropriate staffing levels and the most effective methods of recruiting, hiring, and retaining staff within DYFS. In addition, the bill directs the Department of the Treasury to allocate additional positions to DYFS for fiscal year 2002, and requires a review of certain personnel and compensation issues within the division.

Finally, the bill appropriates \$12 million from the General Fund to the Department of Human Services to effectuate its purposes. These funds, however, have already been appropriated as part of the FY 2001-2002 State Budget. As such, the appropriation set forth in the bill is duplicative.

b. title reevaluations for certain Division of Youth and Family Services direct care positions;

- c. retention and hiring bonus programs, or both, for certain DYFS direct care positions;
- d. career opportunities for DYFS direct care staff; and

e. title series for clerical staff, with objectives of consolidating and upgrading those titles and establishing bridge titles for DYFS clerical staff that bridges into the professional or paraprofessional job titles.

9. This act shall take effect immediately.
