functions granted to it by the Chief Technology Officer and (2) the Chief Technology Officer shall be responsible for the review and approval of any function of the office which is the responsibility of the 9-1-1 Commission. Membership on the advisory commission shall not disqualify a person from membership on the 9-1-1 Commission.

2. This act shall take effect immediately.
