The design would include a gold star and the words "Gold Star Family." Family is defined to mean spouse, parent, brother, sister, child, legal guardian or other legal custodian, whether of the whole or half blood or by adoption. The types of proof needed to show familial relationship includes certification from the New Jersey section of the American Gold Star Mothers, Inc., or a federal DD Form 1300 (Report of Casualty). The New Jersey section of the American Gold Star Mothers, Inc., will design the license plates, to be approved by the Chief Administrator of the New Jersey Motor Vehicle Commission. The amendments removed the fees charged for the plates.

Senate Bill No. 2192 (1R) is identical to Assembly Bill No. 1958 (1R) of 2010.

COMMITTEE AMENDMENTS

The committee amended the bill to change the name of the license plates from Gold Star Parent to Gold Star Family. The amendment also defined family as well as clarified the types of proof needed to show familial relationship, authorized the New Jersey section of the American Gold Star Mothers, Inc., to design the license plates, to be approved by the Chief Administrator of the New Jersey Motor Vehicle Commission, and removed the fees charged for the plates.

The chief administrator may designate a representative of the New Jersey section of the American Gold Star Mothers, Inc., or any other organization formed for the support of parents of members of the armed services who lost their lives while on active duty for the United States, to shall serve as a liaison between such organization and the commission. The chief administrator may require an applicant for a Gold Star Family license plate to submit the application to the representative for approval, which application shall then be forwarded to the chief administrator for final approval.

Senate Bill No. 2192 (1R) does <u>not</u> contain a previous provision of the bill as introduced that authorized a fee to be collected for the cost of the plates. The bill will remain inoperative until the chief administrator certifies that the commission is able to issue the Gold Star Family license plate as a flat, digital license plate, but the bill will not remain inoperative later than the first day of the sixth month after enactment.

The MVC has not provided fiscal information on this bill and the Office of Legislature Services cannot estimate the cost that the Commission might bear.
