The Assembly Judiciary Committee reports favorably Assembly Bill No. 601.

Currently, compensation for jurors is \$5 per day, paid for by State funds. Under this bill, any county board of chosen freeholders would be authorized to pay jurors in the county an additional amount from county funds, up to a maximum additional amount of \$45. Payment of any additional amount would be at the option of the county freeholders. Jurors in the counties which decide to pay the maximum would then be compensated a total of \$50 per day of service.

Procedurally, the State would administer the payment of the additional compensation on behalf of any county that chooses it; the county would then reimburse the State for these added expenditures.

This bill was prefiled for introduction in the 2000 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.

The Assembly Appropriations Committee reports favorably an Assembly Committee Substitute for Assembly Bill No. 601.

This Assembly Committee Substitute for Assembly Bill No. 601 increases the rate of juror compensation for certain jurors.

Currently, compensation for jurors is \$5 per day. This substitute provides an additional \$35 per day (for a total reimbursement of \$40) for most jurors for each consecutive day of attendance in excess of three days. For this purpose a "consecutive" day is measured without regard to Saturdays, Sundays, State holidays or days when a trial is in recess (trials frequently recess on Friday, when related motions are heard). The substitute excepts the State and local government employees who are, pursuant to N.J.S.2B:20-16, fully compensated at their regular rates of pay while attending court for jury service from receiving these additional amounts of pay.

FISCAL IMPACT:

Based on information provided by the Administrative Office of the Courts from available 1999 data collected through the automated jury management system, there were 132,699 juror days served that were consecutive days of attendance in excess of three days. Based on this figure, paying the additional \$35 compensation for each of those days in excess of three days to jurors would cost the State a total of \$4.64 million, assuming that all jurors are from the private sector. However, this cost estimate is overstated because it is probable that State and local governmental employees served as jurors.

Current State law (N.J.S.2B:20-16) fully compensates State and local government employees who serve as jurors at their regular rates of pay less the amount of per diem fee paid for each day of juror service. However, because the AOC does not currently retain records regarding the juror's employer, it is not possible to estimate how many State and local government employees served as jurors in 1999. The cost to implement this bill will be less than \$4.6 million.

For this purpose a "consecutive" day is measured without regard to Saturdays, Sundays, State holidays or days when a trial is in recess.

The amendments adopted by the committee appropriate \$4.6 million dollars to the AOC to cover additional juror costs. The amendments also clarify that public employees entitled under the provisions of N.J.S.2B:20-16 to their usual compensation while on jury duty would not be eligible for juror fees.

The Senate Budget and Appropriations Committee reports favorably Assembly Bill No. 601 ACS (1R).

Currently, compensation for jurors is \$5 per day. This bill provides that, for each consecutive day of attendance in excess of three days, jurors would be eligible for an additional \$35 per day (i.e., for a total per diem reimbursement on those days of \$40). For this purpose a "consecutive" day is measured without regard to Saturdays, Sundays, State holidays or days when a trial is in recess.

The bill also clarifies that public employees, entitled under the provisions of N.J.S.2B:20-16 to their usual compensation while on jury duty, would not be eligible for juror fees.

The bill appropriates from the General Fund to the Administrative Office of the Courts the sum of \$4.6 million to fund the increased payments to jurors for which the legislation provides.

The provisions of this bill are identical to those of Senate Bill Nos. 556, 907, 1275 and 1398 (SCS), which the committee also reports this day.

FISCAL IMPACT

Based on information provided by the Administrative Office of the Courts from available 1999 data collected through the automated jury management system, there were 132,699 juror days served that were consecutive days of attendance in excess of three days. Based on this figure, paying the additional \$35 compensation for each of those days in excess of three days to jurors would cost the State a total of \$4.64 million, assuming that all jurors are from the private sector. However, this cost estimate is overstated because it is probable that State and local governmental employees served as jurors.

FISCAL ANALYSIS

EXECUTIVE BRANCH

The Administrative Office of the Courts (AOC) states that data obtained from the Division of Trial Court Services indicate that there were 487,379 juror days (both petit and grand jury) during calendar year 1999. Based on this, a \$15 per day increase in the juror reimbursement rate would result in a \$7,310,685 increase in annual State expenditures.

The AOC further notes that the \$5,000 appropriation provided in the bill would be sufficient to fund the proposed juror compensation survey.

The Senate Judiciary Committee reports favorably a committee substitute for Senate Bill Nos. 556, 907, 1275 and 1398.

Currently, compensation for jurors is \$5 per day. This bill would provide an additional \$35 per day (for a total reimbursement of \$40) for jurors for each consecutive day of attendance in excess of three days. For this purpose a "consecutive" day is measured without regard to Saturdays, Sundays, State holidays or days when a trial is in recess.

The bill appropriates \$4.6 million dollars to the AOC to cover additional juror costs. The bill also clarifies that public employees entitled under the provisions of N.J.S.2B:20-16 to their usual compensation while on jury duty would not be eligible for juror fees.

The Senate Budget and Appropriations Committee reports favorably Senate Bill Nos. 556, 907, 1275 and 1398 (SCS).

Currently, compensation for jurors is \$5 per day. This bill provides that, for each consecutive day of attendance in excess of three days, jurors would be eligible for an additional \$35 per day (i.e., for a total per diem reimbursement on those days of \$40). For this purpose a "consecutive" day is measured without regard to Saturdays, Sundays, State holidays or days when a trial is in recess.

The bill also clarifies that public employees, entitled under the provisions of N.J.S.2B:20-16 to their usual compensation while on jury duty, would not be eligible for juror fees.

The bill appropriates from the General Fund to the Administrative Office of the Courts the sum of \$4.6 million to fund the increased payments to jurors for which the legislation provides.

The provisions of this bill are identical to those of Assembly Bill No. 601 ACS (1R), which the committee also reports this day.

FISCAL IMPACT:

Based on information provided by the Administrative Office of the Courts from available 1999 data collected through the automated jury management system, there were 132,699 juror days served that were consecutive days of attendance in excess of three days. Based on this figure, paying the additional \$35 compensation for each of those days in excess of three days to jurors would cost the State a total of \$4.64 million, assuming that all jurors are from the private sector. However, this cost estimate is overstated because it is probable that State and local governmental employees served as jurors.

Current State law (N.J.S.2B:20-16) fully compensates State and local government employees who serve as jurors at their regular rates of pay less the amount of per diem fee paid for each day of juror service. However, because the AOC does not currently retain records regarding the juror's employer, it is not possible to estimate how many State and local government employees served as jurors in 1999. The annual cost to implement this bill will be less than \$4.6 million.

DIFRANCESCO SIGNS LEGISLATION INCREASING JURY DUTY COMPENSATION

Acting Governor Donald T. DiFrancesco today signed the following legislation into law:

A-601 sponsored by Assemblymembers Joan Quigley (D-Bergen/Hudson), Richard Bagger (R-Middlesex/Morris/Somerset/Union), Anthony Impreveduto (D-Bergen/Hudson), John Gibson (R-Cape May/Atlantic/Cumberland), Kenneth LeFevre (R-Atlantic) and Nia Gill (D-Essex), increases compensation for jurors from \$5 per day to \$40 for each consecutive day of jury service in excess of three days.

"This increase for jurors is long overdue. I fully support fair compensation for the New Jersey citizens fulfilling their jury duty obligation - a key component of our justice system," remarked DiFrancesco.

Jurors already compensated from their employers for jury service are exempt.

A-2517, sponsored by Assemblymen Leonard Lance (R-Warren/Hunterdon/Mercer) and Michael Arnone (R-Monmouth) and co-sponsored by Assemblymembers Ken LeFevre (R-Atlantic) and Mary Previte (D-Camden), allows problem gamblers to request placement on the Casino Control Commission's (CCC) list of individuals to be excluded and ejected from any licensed casino or simulcasting facility.

In addition to helping problem gamblers to help themselves, the bill requires the CCC to circulate regulations compelling casinos to establish internal controls for removing voluntarily excluded individuals from mailing lists and for denying access to check-cashing privileges, special club programs and the issuance of credit.

A licensed casino shall not be liable in a court proceeding for any harm, monetary or otherwise, that might arise from the failure of the casino to withhold or restore gambling privileges to a self-excluded person.

S-82, sponsored by Raymond Zane (D-Salem/Cumberland/Gloucester), allows duplicate personalized license plates on both owned and leased vehicles.

This bill permits the lessee or owner of a motor vehicle who obtains personalized license plates to obtain a second set of those plates for use on additional vehicles he or she owns or leases. In the past, personalized plates could not be put on leased vehicles.

S-1577, sponsored by Senator Gerald Cardinale (R-Bergen) extends a grandfather clause to November 1, 2002 to allow applicants for a master plumber's license to use employment or schooling to satisfy certain newly enacted eligibility requirements.

The State Plumbing License Law was amended in 1998 to require applicants for the master plumbing license examination to complete a four-year apprentice program approved by the Department of Labor (DOL). This legislation extends a prior grandfather clause by four years to allow employment or schooling in a program not approved by DOL to be substituted for a year of the approved apprenticeship program if performed prior to November 1, 2002.

S-463, sponsored by Senator Robert Singer (R-Burlington/Monmouth/Ocean), prohibits the use of certain materials to mark property boundaries unless it is clearly visible.

It was introduced in response to a tragic accident in which an all-terrain vehicle operator was killed as a result of driving into a non-visible cable being used as a fence in a wooded area

This legislation makes it a fourth-degree criminal offense to use wire, cable, or other similar devices as fencing material installed at a height under 10 feet, if it is not readily visible to pedestrians, equestrians, bicyclists or off-road vehicle operators, and poses a risk of causing significant bodily injury.
