The Senate Judiciary Committee reports favorably Senate Bill No. 2688.

P.L.2001, c.246 created the Domestic Security Preparedness Task Force. Under the provisions of Chapter 246, on the first day of the 65th month following enactment, the Governor is to give notice to the Legislature to review the conduct and performance of the task force. The Domestic Security Preparedness Task Force is to continue to exist unless the Legislature by a two-thirds majority of each house passes a resolution finding either that the task force had failed to perform its duties or that the task force is no longer necessary. This bill would clarify this "sunset provision" by providing that the Legislature would have a 60 day period to complete its review of the performance of the Domestic Security Task Force.

The Assembly Law and Public Safety Committee reports favorably Senate Bill No. 2688.

Senate, No. 2688 amends the "Domestic Security Preparedness Act," P.L.2001, c.246 (C.App.A:9-64 et seq.) to clarify the "sunset" provisions as they apply to the Domestic Security Task Force.

The act affords the Legislature an opportunity to dissolve the task force. Under the provisions of the law, the Governor is to notify the Legislature to review the conduct and performance of the Domestic Security Preparedness Task on the first day of the 65th month following enactment. If, after conducting its review, the Legislature fails to adopt, by a two-thirds majority of each House, a joint resolution finding that the task force should be dissolved either because it has failed to adequately perform its statutory duties or that it is otherwise no longer necessary, the task force is to continue.

In its current form, however, the law does not include a specified time frame within which the Legislature must respond to the Governor's call for a review of the task force's conduct and performance.

The amendatory language set forth in Senate, No.2688 would establish such a time frame. The bill would provide that the Legislature has 60 days in which to respond to the Governor's notice to review the conduct and performance of the task force.

CHAPTER 455

AN ACT concerning the Domestic Security Preparedness Task Force and amending P.L.2001, c.246.

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

1. Section 15 of P.L.2001, c.246 (C.App.A:9-77) is amended to read as follows:

C.App.A:9-77 Effective date, continuance of task force.

15. This act shall take effect immediately; provided, however, that on the first day of the 65th month following enactment the Governor shall give notice to the Legislature to review the conduct and performance of the Domestic Security Preparedness Task Force. If within 60 days of the receipt of that notice the Legislature fails to adopt, by a two-thirds majority of each House, a joint resolution finding that the task force as formulated under this act has either failed to adequately perform its duties pursuant to this act or that the task force is no longer necessary to preserve, protect and sustain the domestic security and preparedness and, therefore shall be dissolved, the task force shall continue.

2. This act shall take effect immediately.
