This bill, as amended, would increase the membership of the Board of Public Utilities ("board") from three to five citizen members, and no more than three of whom are of the same political party. The board has a wide range of responsibilities over complex issues, including the responsibility of ensuring that consumers benefit from the restructuring and deregulation of the electricity, natural gas, telecommunications industries. Increasing the membership of the board will help ensure that these issues are addressed effectively, thoroughly and efficiently. Increasing the membership will also ensure that quorum requirements are met and that the important business of the board can continue when a single member is absent due to illness or recusation.

The amendments adopted by the committee establish a phase-in period that provides for two members of the board to constitute a majority until a fourth member is appointed and confirmed at which time three members will constitute a majority. Upon appointment and confirmation of a fifth member, the provisions of R.S.48:2-40, which require a majority vote of the board to adopt an order, shall be applicable.

The addition of two members to the Board will impact the activity and costs of the various divisions of the BPU, which is expected to be absorbed by the current organization.

Each commissioner will receive a salary, currently \$105,000 per year, and is authorized to hire sufficient support staff pursuant to R.S.48:2-2, such as executive staff assistants, secretaries, and confidential assistants. Each commissioner is expected to require at least two support staff. Based on current staffing and salary levels, the OLS estimates a combined cost of approximately \$294,500 per commissioner, for a total of over \$589,000 in the first year. Costs will increase in future years from cost of living step increases.

The Board has statutory authority to assess fees on regulated industries to support its operating expenses, pursuant to P.L.1972, c.36 (C.48:2-59). Therefore, the bill will not impact the General Fund.

The bill establishes a phase-in period that provides for two members of the board to constitute a majority until a fourth member is appointed and confirmed at which time three members will constitute a majority. Upon appointment and confirmation of a fifth member, the provisions of R.S.48:2-40 shall be applicable.

The addition of two members to the Board will impact the activity and costs of the various divisions of the BPU, which is expected to be absorbed by the current organization.

Each commissioner will receive a salary, currently \$105,000 per year, and is authorized to hire sufficient support staff pursuant to R.S.48:2-2, such as executive staff assistants, secretaries, and confidential assistants. Each commissioner is expected to require at least two support staff. Based on current staffing and salary levels, the OLS estimates a combined cost of approximately \$294,500 per commissioner, for a total of over \$589,000 in the first year. Costs will increase in future years from cost of living step increases.

The Board has statutory authority to assess fees on regulated industries to support its operating expenses, pursuant to P.L.1972, c.36 (C.48:2-59). Therefore, the bill will not impact the General Fund.

The Assembly Appropriations Committee reports favorably Assembly Bill No. 3289 (1R).

Assembly Bill No. 3289 (1R) increases the membership of the Board of Public Utilities ("board") from three to five members, no more than three of whom are to be of the same political party. The board has a wide range of responsibilities over complex issues, including responsibility for ensuring that consumers benefit from the restructuring and deregulation of the electricity, natural gas, and telecommunications industries. Increasing its membership will better enable the board to address these issues effectively, thoroughly and efficiently, and help to ensure that quorum requirements are met and that the business of the board can continue when a member is absent due to illness or recusal.

The bill as reported is identical Senate Bill No. 2298 (1R) as also reported by the committee.

FISCAL IMPACT:

The Office of Legislative Services (OLS) notes that increasing the membership of the Board of Public Utilities by two members will result in increased operating expenses for the Board; these costs include direct (salaries, materials and supplies) and indirect (fringe benefits) expenses of the additional members and their staff. Overhead expenses are expected to be minimal, as excess office space is currently available. The addition of two members to the Board will impact the activity and the costs of the various divisions of the BPU, which is expected to be absorbed by the current organization.

Each commissioner will receive a salary, currently \$105,000 per year, and is expected to require at least two support staff. Acting Governor Donald T. DiFrancesco signed the following legislation today:

S-2450, sponsored by Senators Peter Inverso (R-Mercer/Middlesex) and John Matheussen(R-Camden/Gloucester) and Assemblymembers Nicholas Asselta (R-Cape May/Atlantic/Cumberland) and Joseph Azzolina (R-Middlesex/Monmouth), increases the retirement benefits under the Teachers' Pension and Annuity Fund (TPAF) and The Public Employees' Retirement System (PERS) for service, deferred and early retirement by changing the formula from 1/70 to 1/64 to final compensation for each year of Class A service and from 1/60 to 1/55 of final compensation for each year of Class B service.

The bill also increases the retirement benefit for TPAF and PERS veteran members with 35 or more years of service and reduces the age qualification from 60 to 55.

The bill also provides for a reduction in TPAF member contributions.

S-2465, sponsored by Assemblyman Joseph Malone (R-Burlington/Monmouth/Ocean) and Senator Walter Kavanaugh (R-Morris/Somerset), requires providers of goods and services to the State and its agencies or to casino licensees, and any subcontractor under those State and casino contracts, to register their businesses with the Division of Revenue.

S-1581, sponsored by Senators Gerald Cardinale (R-Bergen) and Richard Codey (R-Essex) and Assemblymen Kip Bateman (R-Morris/Somerset) and Joseph Doria (D-Hudson), allows an existing health service corporation, or any health corporation formed in the future, to convert from a non-profit health service to a for-profit domestic stock health insurer. As a condition of this conversion, the corporation is required to establish a charitable foundation and contribute to it the fair market value of the health service corporation at the time of the conversion to satisfy the charitable obligations of the converting corporation to the people of the State of New Jersey.

S-2298, sponsored by Senators Martha Bark (R-Atlantic/Burlington/Camden) and Bernard Kenny (D-Hudson) and Assemblymembers Paul DiGaetano (R-Bergen/Essex/Passaic) and Joseph Doria (D-Hudson), increases the membership of the Board of Public Utilities (BPU) from three to five members, no more than three of whom are to be of the same political party.

A-3045, sponsored by Senator Anthony Bucco (R-Morris) and Assemblyman Guy Gregg (R-Sussex/Hunterdon/Morris), closes a gap in the administration of the taxes imposed on the owners of limited partnerships and limited liability companies.
