STATEMENT

The purpose of this bill is to create a Crime Prevention Coordinating Council in the Department of Law and Public Safety.

The council's duties would include establishing standards for training programs in crime prevention to be offered at police training schools in the State; establishing minimum standards for crime prevention programs in local police departments; creating a crime prevention resource center; and instructing local police departments on ways of obtaining and utilizing local financial resources from crime prevention programs.

The bill also amends the law that outlines the duties of the Police Training Commission, so that the Crime Prevention Coordinating Council and not the Police Training Commission would be responsible for approving the courses in crime prevention offered at schools approved by the Police Training Commission.

The Crime Prevention Coordinating Council would consist of 14 members: the Attorney General, who would be the chairman of the council; the Commissioner of the Department of Community Affairs; the Commissioner of the Department of Commerce and Economic Development; the Commissioner of Education; the Director of the Division of Criminal Justice; the Superintendent of State Police; a representative of the Police Training Commission; a representative of the New Jersey Crime Prevention Officers' Association, a representative of the New Jersey State Association of Chiefs of Police, a representative of the National Crime Prevention Council, a representative of a public utility company, a representative of the insurance industry, a representative of the banking industry, and one other citizen.

The bill appropriates \$75,000.00 to the council from the General Fund to implement the provisions of the act.

DATED: MARCH 1, 1984

The purpose of Senate Bill No. 826, as amended by the Senate Law, Public Safety and Defense Committee, is to create a Crime Prevention Coordinating Council in the Department of Law and Public Safety.

According to Senate Bill No. 826 as amended by the committee, the council's duties would include recommending standards for training programs in local police departments; creating a crime prevention rein the State; establishing minimum standards for crime prevention programs in local police departments; creating a crime prevention resource center; and instructing local police departments on ways of obtaining and utilizing local financial resources for crime prevention programs.

The bill also amends the law that outlines the duties of the Police Training Commission so that the Crime Prevention Coordinating Council would recommend to the Police Training Commission courses in crime prevention offered at schools approved by the Police Training Commission.

The Crime Prevention Coordinating Council would consist of 14 members: the Attorney General, who would be the chairman of the council; the Commissioner of the Department of Community Affairs; the Commissioner of the Department of Commerce and Economic Development; the Commissioner of Education; the Director of the Division of Criminal Justice; the Superintendent of State Police; a representative of the Police Training Commission, a representative of the New Jersey Crime Prevention Officers' Association; a representative of the New Jersey State Association of Chiefs of Police; a representative of the National Crime Prevention Council; a representative of a public utility company; a representative of the insurance industry; a representative of the banking industry; and one other citizen.

The bill appropriates \$75,000.00 to the council from the General Fund to implement the provisions of the act.

The Senate Law, Public Safety and Defense Committee amended Senate Bill No. 826 so that the Crime Prevention Coordinating Council would recommend to the Police Training Commission courses of study in crime prevention offered at schools approved by the Police Training Commission. As originally written, Senate Bill No. 826 would have given the authority to approve these courses, which is now granted to the Police Training Commission by law, adopted by this amendment in order to preserve the Police Training Commission's authority regarding the training of police officers and in order to eliminate the potential duplication of effort that would have resulted from giving two entities in the Department of Law and Public Safety authority over different aspects of the training of police officers.

SENATE BILL NO. 826 (OCR)

To the Senate:

Pursuant to Article V, Section I, Paragraph 14 of the Constitution, I am returning Senate Bill No. 826 (OCR) with my objections, for reconsideration.

The purpose of this bill is to create a Crime Prevention Coordinating Council which would recommend standards for training programs in crime prevention to be offered at police training schools in the State and to recommend the curriculum, the minimum courses of study, attendance requirements, and minimum qualifications for instructors and programs in local police departments. It will also create a crime prevention resource center and instruct local police departments on ways of obtaining and utilizing local financial resources or crime prevention programs. This bill appropriates \$75,000.00 to the council from the General Fund to implement the provisions of the act.

While I strongly support the standardization of training for our police forces across the State and the increased training of our officers in order to insure that the citizens of New Jersey continue to be served and protected by the best and most professional police forces in the country, I am opposed to creating another level of bureaucracy by creating another council concerning training police officers for crime prevention. Presently, the Police Training Commission (PTC), established in the Department of Law and Public Safety has the power, responsibility and duty to prescribe the schools, curriculum, and minimum courses of study, to be used in the training of policemen at county and municipal levels. This is provided for in our statutes in section 6 of P.L. 1961, c. 56 (C. 52:178-71).

If created, the Crime Prevention Coordinating Council would have the responsibility for recommending courses, standards, and training programs concerning crime prevention to the Police Training Commission. It is unnecessary to have two council's duplicate efforts, staff and finances to accomplish the same goal. Another responsibility the Crime Prevention Coordinating Council would have is that of creating a crime prevention resource center. A part of the resource center's duties would be to instruct local police departments on ways of obtaining and utilizing local financial resources

for crime prevention programs in municipalities and to provide materials, information and technical assistance throughout the State in the area of crime prevention.

Both of these tasks could be accomplished by the existing Police Training Commission. Not only can these responsibilities be accomplished in the PTC, they can be accomplished within the existing administrative structure saving countless dollars which would be needed to staff, house and organize a Crime Prevention Coordinating Council. This bill appropriates \$75,000 from the General Fund to enable the Crime Prevention Coordinating Council to implement the provisions of this act. The PTC could accomplish the goals intended by this act without the costs associated with creating another council. While I do not believe we need to create another council in State government, I whole-heartedly support the concepts behind this bill. I therefore propose that an advisory committee be established in the PTC to accomplish the same features of this bill and that \$10,000 be appropriated to enable them to establish the committee. By creating an advisory committee located within the PTC, there would be little expense generated by this bill, and the PTC would remain the coordinating body for all police training courses in the State. Another reason for creating an advisory committee within the PTC is that seven of the fourteen members of the proposed Crime Prevention Coordinating Council are already members of the PTC.

While I stated above that the PTC has sought the establishment of a crime prevention resource center and could accomplish these responsibilities, the current charter of the PTC is to prescribe schools, curriculum, and minimum courses of study to be used in training policemen in the State. It does not provide technical assistance to police departments. Such assistance is provided to police departments by the State Police through the State Police Academy in Sea Girt. I feel the State Police Academy would be better suited to act as a clearing house for crime prevention information to be made available to municipal police departments. I therefore propose that the crime prevention resource center be established in the Division of the State Police and that \$25,000.00 be appropriated to enable them to establish the center.
