Senate Bill No. 1830 supplements Title 33 of the Revised Statutes to permit the governing board or body of any municipality to issue a plenary retail consumption license to certain nonprofit corporations which conduct musical or theatrical performances or concerts.

Under the provisions of the bill, the governing board or body would be permitted to issue a plenary retail consumption license for on premises consumption, upon the approval of the Director of the Division of Alcoholic Beverage Control, to a nonprofit corporation which conducts musical or theatrical performances or concerts in a structure which has a seating capacity of 1,000 or more persons. The bill specifies that the sale of alcoholic beverages is to be for a limited time period, commencing one hour before the beginning of any performance and continuing through the hour immediately following the conclusion of the performance.

A license issued pursuant to the provisions of this bill is not to be counted in determining the maximum number of liquor licenses a municipality is permitted to issue under the provisions of P. L. 1947, c. 94 (C. 33:1–12.13 et seq.) or P. L. 1968, c. 277 (C. 40:48–2.40 et seq.).

The purpose of Senate Bill No. 1830 is to permit the governing board or body of any municipality to issue a plenary retail consumption license to certain nonprofit corporations that conduct musical or theatrical performances or concerts.

After receiving the approval of the Director of the Division of Alcoholic Beverage Control, the governing board or body of a municipality would be permitted to issue a plenary retail consumption license to a nonprofit corporation that conducts theatrical performances or concerts on premises with a seating capacity of 1,000 persons or more.

The license would authorize the sale of alcoholic beverages for consumption on the licensed premises during a performance and during the hour immediately preceding and the hour immediately following a performance.

A license issued under the abovementioned provisions would not be counted in determining the number of licenses a municipality is permitted to issue.

S-1830, sponsored by State Senator Donald T. DiFrancesco, R-Union, which permits a municipal governing body to issue a plenary retail consumption license to a nonprofit corporation which conducts performances on a premises of 1,000 seats or more, with alcoholic beverage sales limited to a performance and the hour immediately preceding and following the performance.

A-4, sponsored by Assemblyman Richard A. Zimmer, R-Hunterdon, which prohibits the destruction of agricultural or recreational property by a motor vehicle and directs the Director of the Division of Motor Vehicles to establish motor vehicle points to be assessed against the driving record of any person found guilty of such an offense.
